



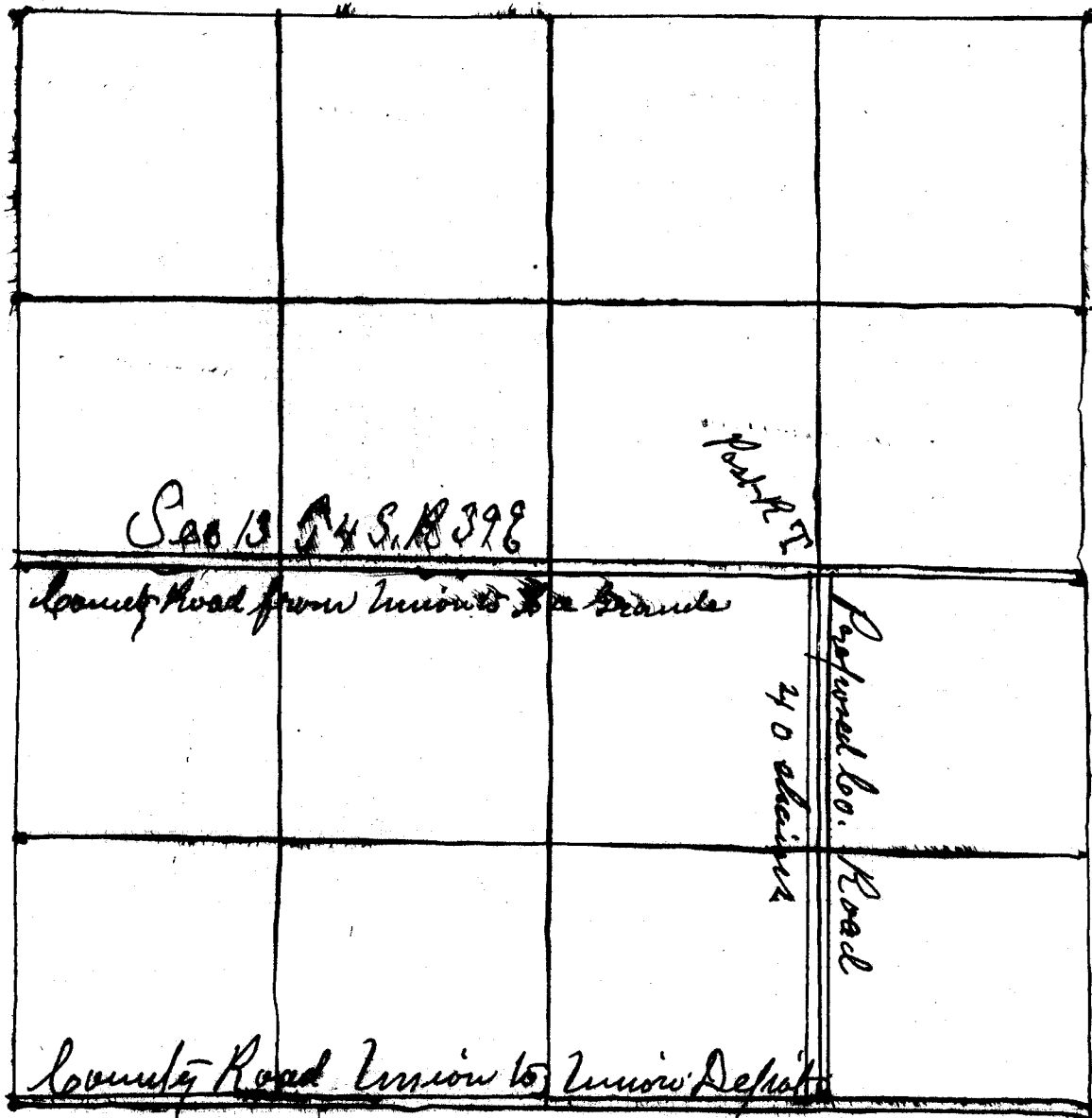

T. 4. S. R. 39 E. of N. W. Thence due north one half mile to intersect the county road leading from Lay Grand to Union, which said point shall be the terminus of said proposed county. And in appearing to the satisfaction of the Court that due and legal notice of the pendency of this proceeding had been given as by law required in such cases made and provided that a good and sufficient bond has been filed herein, and that more than twelve of said petitioners are resident householders residing in the vicinity of said proposed road It is therefore hereby ordered that A. B. Robinson John Reach and Steve Connor be appointed assessors and Moses Austin Jurvey or to view survey and report upon said proposed road and that they meet at the house of M. S. Warren on Saturday July 18th 1885 at 10 o'clock A. M. and duly qualify before entering upon the discharge of their duties in this behalf.
