I, E. F. Roberts, being first duly sworn, on my oath say:

I am the owner in fee simple of Lot No. 4 and the S.W. 1/4 of the N.W. 1/4 of sec. 1, and Lot No. 1 and the S.E. 1/4 of the N.E. 1/4 of sec. 2 in Tp. 1 N. of R. 40 E. W. 1/2 in Union County, Oregon.

The county road from Elgin to the Wallowa Bridge cuts across a small corner of the north west corner of my Lot one, above described; so as to render my land on the north west side of said road wholly useless to me although the same is good agricultural land.

If I should be permitted to fence in my said Lot one so as to turn the said road around my said north west corner it would increase the distance on said road not to exceed about 125 yards, and the grade of said road would be almost as good and I believe quite as good as it now is.

It would cost me about as much as the said small corner of land is worth to get up a regular petition and to have the necessary proceedings taken to have the said change in the said road made in the usual manner of vacating or establishing roads.

The said change, if allowed, would be a small and immaterial change in the said road, but would be of great benefit to me.

Should the change be allowed the road would be fully as good a road as it now is.

Should the change be allowed I hereby promise and agree to do any thing which may or might be required of me by the road supervisor of that district to be done upon the said road where changed to make the condition of the said road satisfactory to the said supervisor.

We, the undersigned, beg leave to submit this our report in the above  
entitled matter:

First. Before entering upon our duties as reviewers herein, we and each of  
us severally took an oath that he would support the Constitution of the  
United States, the Constitution of the State of Oregon, and faithfully  
discharge the duties of reviewer in the above entitled matter to the  
best of his ability, so help him God.

Second. On Saturday, the 28th day of March, 1902, the same being the day ap-  
pointed on which we were to meet, we met at the residence of E. F. Roberts  
in Union County, Oregon, and proceeded to review and survey the ground  
over which the said road is proposed to be turned, and to ascertain the  
distance such road will be increased by the proposed alteration: thereupon  
we found that the distance from where the said road intersects the west  
line of Lot one in sec. two, T. 1 N. of R. 40 E. W. M. in Union County, Oregon,  
to where said road intersects the north line of said Lot one, to be  
<sup>506</sup> yards: and the distance from said first mentioned  
point along and near the west line of said Lot one and on said Lot one  
to the N.W. corner of said Lot one, thence along and near the north line  
of said Lot one and on said Lot one to the point on said road secondly  
above mentioned, to be <sup>687 1/2</sup> yards.

Third. That the distance on said road will be increased by the said proposed  
change, a distance of <sup>181 1/2</sup> yards.

Fourth. That in our opinion the making of such proposed alteration would be  
of much utility.

Fifth. The prayer of the petitioner E. F. Roberts in the matter is reasonable  
and should be granted.
