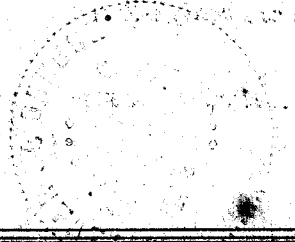

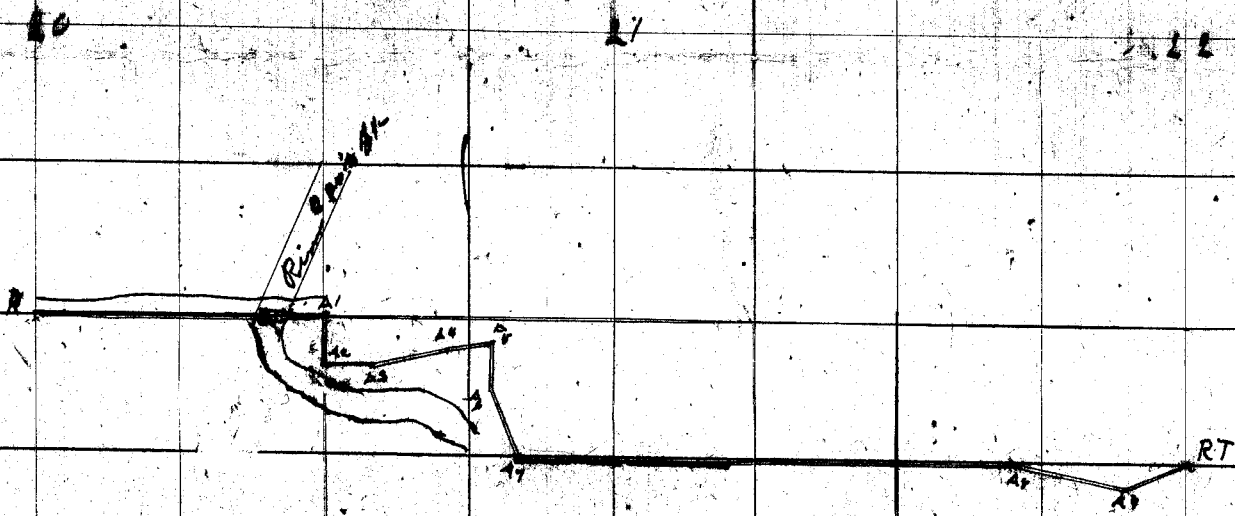

3 That the petition does not describe the lines of the proposed road with sufficient certainty to give the Court jurisdiction, including the beginning, INTERMEDIATE POINTS, and terminal points with sufficient certainty.

4 That the notice of road petition here-in is insufficient to give the Court jurisdiction here-in, in this, that the said notice of road petition herein is undated and does not give the householders inspecting it full information of the intended proceeding.

5 That the proof of publication here-in is insufficient to give the Court jurisdiction, in that it does not describe the place where

be declared a public highway of Union County, Oregon, and all the proceedings herein having been regular and according to law, and no remuneration or claim for damages having been filed herein. And there having been no cause shown why this proposed road should not be declared a public highway and ordered open according to law, and the Court being satisfied from the report of the viewers that such road will be of public utility, It is therefore considered and ordered by the Court that said report of the viewers and surveyor be approved and adopted by the Court that said proposed road be declared a public highway of Union County, Oregon, and ordered up and placed in repair for travel according to law. It is further ordered that the report of the viewers be placed on record in this Journal, and that the Surveyors plat of the proposed road and his field notes of the survey thereof, be placed on record in the book of Plats of County Roads of Union County, Oregon, and that Chas. C. Apple, Road Supervisor of Road District No. 10 the same being the road district in which said road is located, be furnished with a copy of the petition herein, and a copy of this decree and ordered to open up said road and place the same in repair for travel.

In the matter of the proposed County Road petitioned for by Fred W. Young, et al.

This matter came on to be heard at this time on the report of the Viewers and Surveyor heretofore appointed herein for a second reading as provided by law and the report of Viewers being in words following, to-wit:

To the Honorable County Court for Union County, Oregon.

The undersigned Viewers heretofore on the 2nd day of June, 1896, appointed to view and lay out and alter the proposed County road, of which the survey hereto attached is a true and correct description, petitioned for by Fred W. Young et al., has leave to report that on the 29th day of June, 1896, in pursuance with said appointment and order, after being duly sworn to faithfully and impartially discharge the duties of said appointment, we proceeded to view out said proposed road for the whole distance thereof, and that in our opinion said
