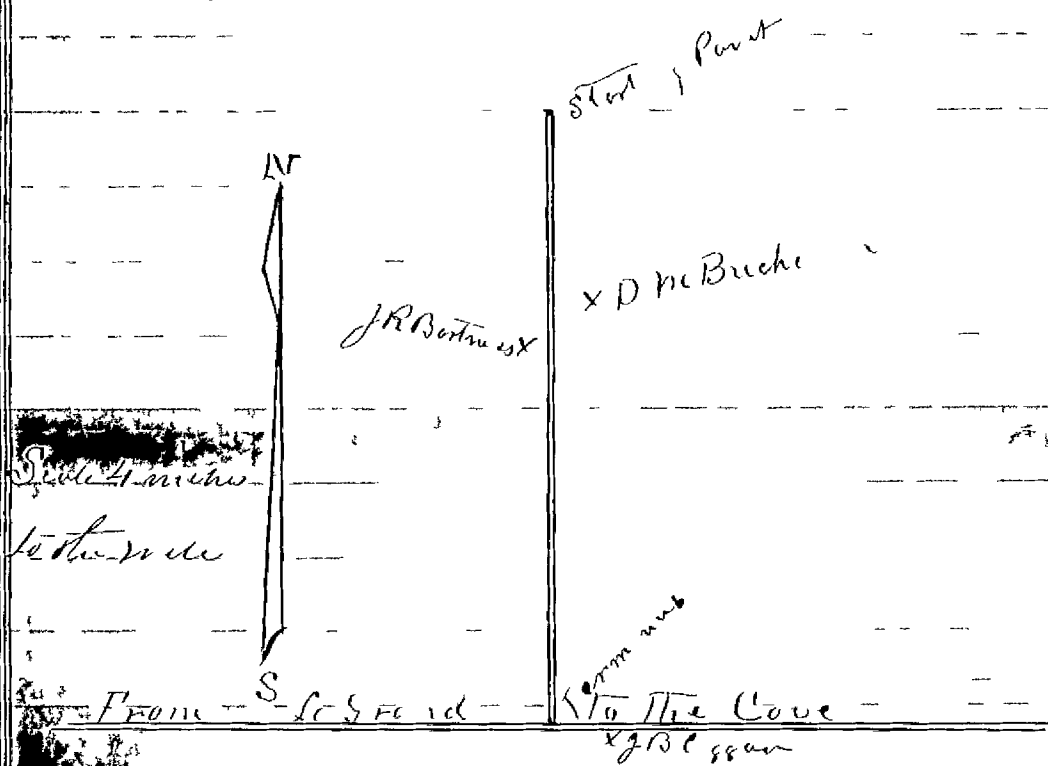

Now at this time was
 presented a petition praying for a Change in
 County Road leading from the N.E. Corner of
 James Bartness field due South to a point
 intersecting the County Road leading from Leland
 to the Cove, and vacating the County Road
 running from North East Corner of James
 Bartness field to the S.W. Corner of E. Greenwolds
 field. And after due consideration by the
 Court it is ordered that the consideration
 of the same be continued until the next
 regular term of this Court.

In the Matter of resignation }
 of J L Morrow Justice of the }
 Peace of Leland Precinct } 3

Now at this time it
 appearing to the Court that J L Morrow had
 tendered his resignation of the Office of Justice of
 the Peace of Leland Precinct in Union County
 which resignation is duly accepted thereby creating
 a vacancy in said Office and whereas a petition
 was presented to the Court praying that R.
 Chewerth be appointed to fill said Vacancy.
 It is therefore Ordered that said R. Chewerth
 be and he is hereby appointed Justice of the Peace of

In the Matter of County

Now on this ^{day} Came up for action the petition heretofore presented, which action had been postponed from term to term to this time, praying for the location of a County Road commencing at the North East corner of James Bartness' field, thence due South to a point connecting with the road from Salmond to the Cove in Said County, and to vacate the road from the place of beginning described in the petition to where the road now intercepts the same road, which petition was signed by twelve or more resident householders residing in the vicinity of Said Road in Said County, which petition was accompanied with a bond approved by the Court also with proof of notices having been duly posted according to law.

It is therefore Ordered that D A McAlister John Bartness and G W Bartness be and they are hereby appointed Viewers of said Road and J S Curtis Surveyor, who are to meet at the house of James R Bartness on the 22nd day of July 1873 and Report their proceedings at the next term of this Court,

Now on this day came up the Viewers Report on its second reading for consideration for a County Road heretofore petitioned for commencing at the North East Corner of James Bartness's fence - thence due South to a point connecting with the road from Salpandre to the Cove in Said County, and to vacate the road from the place of beginning, described in the petition to where the road now intersects the same road. And the Viewers appointed heretofore in said report, ^{subscribed} that said change is practicable and that it would be a benefit to the citizens and traveling public.

It is therefore Ordered that said change be made in accordance with the plat and field notes of the Surveyor accompanying said Report be and the same is hereby declared a public highway, and it is further Ordered that the same be opened and kept in repair as other County Roads by Supervisors having charge thereof in their Districts.
