We the undersigned citizens and householders living in Union County State of Oregon and, residing in the immediate vicinity of and along the line of the hereinafter described road, respectfully petition your honorable body to lay out locate, and establish a County Road as follows To wit Beginning at or near the George Allen House on the Road leading from the town to Summerville then the River - thence in a southerly direction on the East side of the Grande Ronde River passing through the Cornuff Gap - thence along the East side of Hance and Knight's enclosure and through the Messer Gaps thence over the high route to Indian Creek and crossing it at or near Jones' Meadows - thence over the most feasible route, and then thence on the East side of said River at or near the fish traps which road and all of which places mentioned are in Union County and State of Oregon

There will be a petition presented to the Honorable the County Court for Union County State of Oregon at its May Term for the locating and establishing a County Road as follows To wit Beginning at or near the George Allen house on the road leading from the Cove to Summerhill over the Pine Pole - thence in a Northerly direction on the East side of the Grande Ronde River passing through the Cornduff Gap - thence along the East side of Messrs Harris and Knight's enclosures and through the Musser Gap - thence over the best route to Union Creek and crossing it at or near Job Weavers - thence on the most feasible route and terminating on the East side of said River at or near the Fish Trap which road and all of which places mentioned are in Union County and State of Oregon

At a term of the County Court of Union County State of Oregon began and held pursuant to adjournment at the Court House in Selgrand Oregon on the 3rd Wednesday the 21st day of May A.D. 1873 there was present Hon E C Brainerd County Judge John A Childers and J W Kennedy County Commissioners, Arthur Warrick Sheriff and J M Black County Clerk.

Due proclamation of the Opening of Court having been made the following Business was transacted

In the Matter of }

Now on this day was presented and read a petition praying for the location of a County road commencing as follows to wit: at or near the Gorge Allen House on the road leading from the levee to Summerville via Pine tree thence in a northerly direction on the East side of Grande Ronde River, passing through the Carnduff Gap, thence along the East side of Harris and Knight's inclosures and through the Mesner Gap, thence on the best route to Indian Creek crossing it at or near Joel Weavers on the East side of said River at or near the fish trap.

Which petition was laid over until tomorrow for Petitioners to file Bond in pursuance of law.

Court then adjourned until tomorrow at 9 o'clock.
