M.; that there is at present a county road laid out extending through the middle of said section 2, north and south; that petitioner is desirous of changing said county road, commencing at the SW corner of the SE 1/4 of said section 2, and to have the same located as follows:- Commencing at said southwest corner of said southeast quarter of said section two said township and range, and running thence west on a line thirty feet north of the south line of said section two to a point thirty feet east and thirty feet north of the southwest corner of said section two; thence north parallel with the section line, one mile and a half to a point thirty feet east of the southeast corner of the northeast quarter of section thirty-four in township two south of range, thirty-mile east of the Willamette Meridian, there intersecting the main travelled county road leading from Union to Summerville, and to vacate the present county road running north through section two aforesaid.

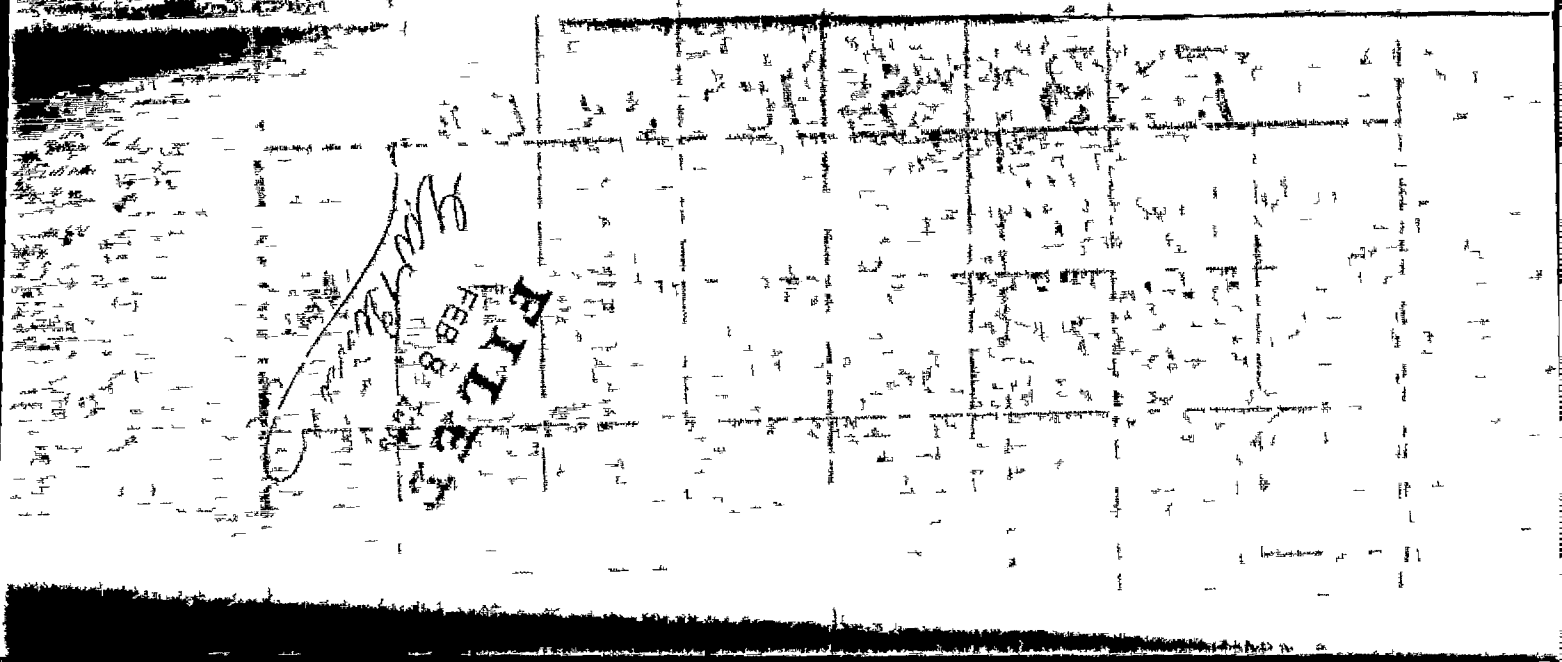

We therefore recommend that said proposed roads be laid out and declared a public highway of said county.
