W. M., thence West on the section line between sections 2 & 11 and 3 & 10 a distance of about one and one half miles to the East bank of Catherine Creek, thence in a Northwesterly direction along the East bank of Catherine Creek to a point where the line between the South half and North half of of the South West quarter of section 3 Tp 4 South Range 39 E. W. M. crosses said Catherine Cree, thence West on said line through said quarter section and through the center of the South half of section 4 Tp. 4 S. R. 39 E. W. M. and continuing West on the line between Lots 7 and 8 in section 5 Tp 4 S. R. 39 E. W. 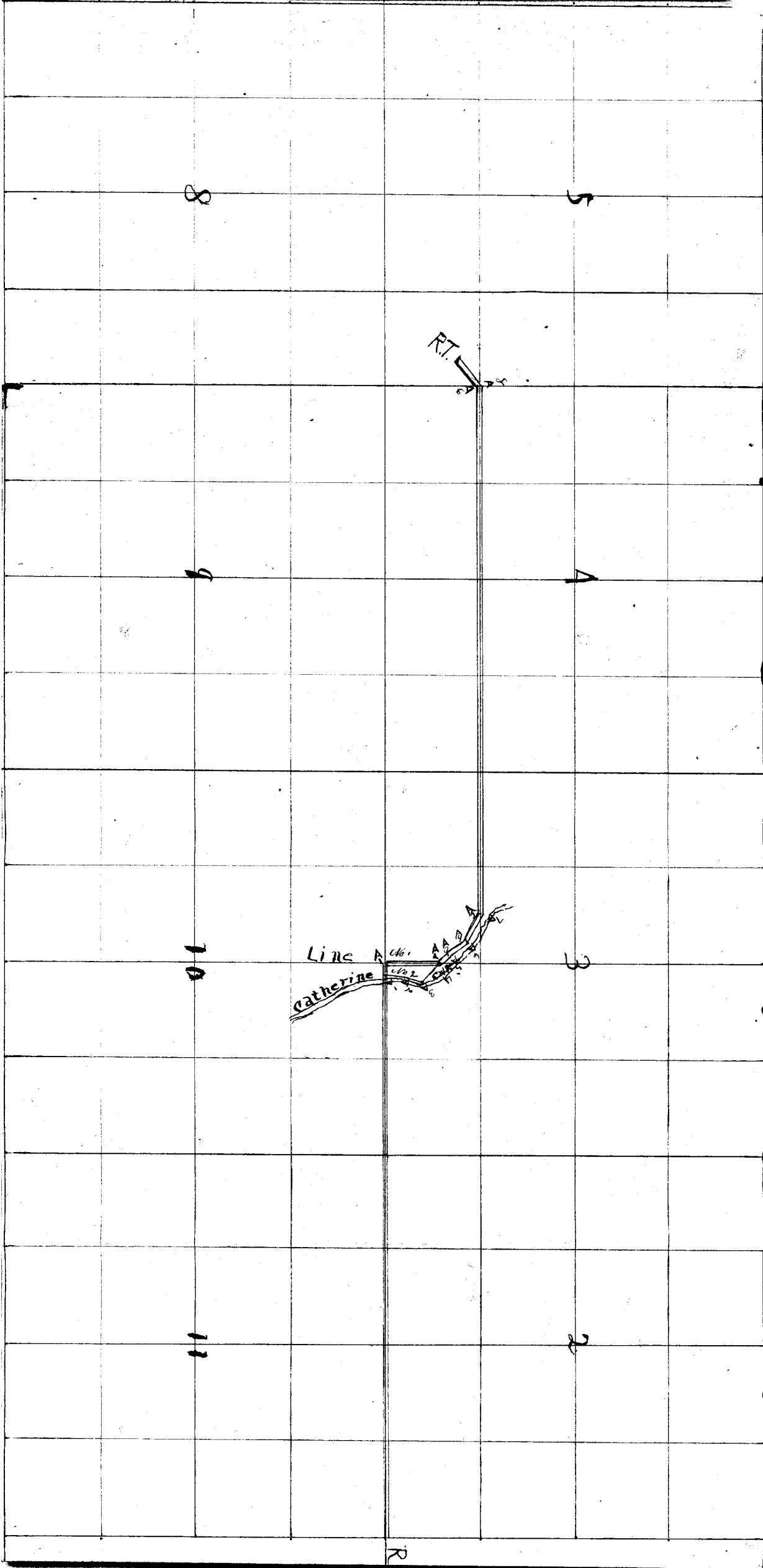

in open Court it is ordered that the same be approved and
adopted It is further ordered that deeds be accepted from
J.E. Foster and Ball Bros for lands 60 feet in width for road pur-
poses in accordance with changes made in the said road

Thereupon it was ordered that Court be now adjourned until tomorrow
morning at 9 o'clock
