Commencing on the Union and Cornucopia road at a point where the said road crosses the north line of the north west quarter of Sec/ 17 in Tp. 5 S.R. 41 E.W.M., thence following S.E. along said road to a point about 100 feet west of the dwelling on the Rinehart place in Sec. 17 Tp. 5 S/R. 41 E.W.M., thence angling nearly south along the west side of Eaton creek over the most practicable route about 400 yards, thence bearing southeasterly on the most practicable route to a point where the said proposed road intersects the south line of said section 17 near the quarter corner, thence east on said section line or near the said line over the most practicable route to where it intersects the Union and Cornucopia road at or near the S.E. corner of said Sec. 17 and there terminate. And we hereby ask that the old road between said points be closed, or vacated. And in duty bound your petitioners will ever pray, &c.

D. 1901, respectfully present to said Court a petition praying said Court to lay out, alter and establish a County road within said County, on the following line or route, to-wit:

Commencing on the Union and Cornucopia road at a point where the said road crosses the north line of the north west quarter of Sec. 17 in Tp. S. Rinehart and others, have petitioned the County Court of said County of Union, at the August Term, 1901 thereof for a County Road, as described in the notice hereto attached, to-wit: Commencing at the Northeast Corner of the N.W. $\frac{1}{4}$  Sec. 16, Tp. 5, S.R. 40 E. W. 
To the Hon. County Court of Union County, Oregon:

Rinehart et al., beg leave to report that on the 2 day of September 1901, in pursuance of said appointment and order, I Surveyed said proposed road for the whole distance thereof, the following being the field notes of said survey:

Commencing at a pine tree marked "P." at a point 10.80 Chs. East of the N.W. Cor. of Sec. 17 T. 58 R. 41 E. Then South  $10^{\circ} 00'$  West 4.50 Chs. to Angle 1 a Rock. Then South  $17^{\circ} 30'$  West 7.90 Chs. to Angle 2 a Pine Tree. Then South  $28^{\circ}$  West 5.80 Chs. to Angle 3 a Tree. Then South  $38^{\circ}$  E. 6.80 Chs. to a tree. Then South  $48^{\circ}$  East 2.250 Chs. to a tree. Then South  $32^{\circ}$  East 6.20 Chs. to a tree. Then South  $48^{\circ}$  East 26.80 Chs. to 1 Mile Line. Same Course 20.08 to Angle 7 a tree in see line. Then East 9.10 Chs. to R.T. a Pine tree on Conneopis Road.
