In the Matter of Vacating  
part of County Road 3

Now on this day  
was presented a petition for the vacating of  
a part of the County Road commencing where  
the Range line dividing Ranges 38 and 39 East  
crosses the Road leading from La Grande to  
the Cove, running thence North on said  
Range line to the road running East and  
West by McGinnesses farm, to wit; that  
part of said road lying North of the North  
Branch of Grand Ronde River, be vacated  
Which petition was signed by over sixty  
Citizens of said County, which petition was  
accompanied by proof of notices having been  
posted in accordance with law more than  
thirty days prior to this time, and no  
remonstrances against said petition having  
been filed,

It is therefore Ordered that all  
that part of said road lying North of  
the North Branch of Grand Ronde River  
be and the same is hereby vacated, and  
from this time shall cease to be a public  
High way

Court then adjourned until to Morrow  
at 9 O'clock,
