IN THE COUNTY COURT OF UNION COUNTY, OREGON.

In the Matter of Laying out and
Establishing a Public Highway.

To the Honorable County Court of Union County, State
of Oregon:

The undersigned householders of Union County, State of Oregon, residing in said county within the vicinity of the hereinafter proposed public highway, hereby petition and ask that said County court lay out and establish a public highway in Union County, Oregon as follows, to-wit: Commencing on the east line of the south half of the northwest quarter of section 17, township three south of range 37, E. W. M., at the road stake marked "A7", the same being the stake placed by the county surveyor of Union County, Oregon, at angle seven of the public highway petitioned for by Gus Benggelsdorff and others, and which road was established by said court on the 6th day of June, 1901; thence running north from said stake on the center line running through said section 17 and section 8 in the same township and range to the northeast corner of the south half of the southwest quarter of said section 8, township three south of range 37 E. W. M., at a mound of rock situated at said corner; thence west along the north line of said south half of the southwest quarter of said section 8, 1/4 mile to the southwest corner of the northeast quarter of the southwest quarter of said section 8; thence in a northwesterly direction to angle stake numbered ten of the said public highway petitioned for by Gus Benggelsdorff and others, and established on the 8th day of June A. D. 1901, the said angle stake being situated in the northeast corner of the north-

east quarter of the southeast quarter of section seven, township three south of range 37, E. W. M., and there terminated. And also to vacate that portion of the public highway petitioned for by Gus Bengelsoff and others on the 8th day of June, A. D. 1901, commencing at angle seven thereof as laid out and established by said county court and marked on the ground, and running thence in a northwesterly direction along said highway to angle stake numbered ten thereof as established by said county court and the county surveyor of Union County, Oregon.
