That if said road is laid out and established as a public highway to Union County, this claimant will have to build one mile of fence, which would cost the claimant at least \$250.00.

Jones, one of the petitioners for the above named proposed County Road, and presents to the Court the petition of himself and others, praying for the location and establishment of a County Road, described as follows, to-wit: Beginning at the Northwest corner of the South one-half of the Southeast Quarter of the Northeast Quarter of Section fifteen, Township three, South Range Forty, E.W.M., running thence East one hundred and forty rods to intersect with the County Road running North and South, east of the George W. Thomas place, said road to be forty feet wide.

And it appearing to the Court, that said petition is signed by more than twelve freeholders of this County, residing in the Road District where the hereinbefore described road is proposed to be, and that said petition properly specifies the place of beginning, intermediate points and place of termination of said road, and it satisfactorily appearing to the Court, that notice has been given by advertisement posted at the place of holding County Court, to-wit: At the Court House, in the City of La Grande, County of Union, State of Oregon, and also in three public places in the vicinity of said proposed road, to-wit: One at the Southeast corner of the O. Eckersley place one half mile North of the School house in Cove, about four feet from the ground, one on the gate post of O.B.
