TO THE HONORABLE COUNTY COURT, FOR UNION COUNTY, OREGON:

The undersigned freeholders, of Union county, Oregon, residing in the Road District where the hereinafter described road is proposed to be, respectfully petition your honorable body to lay out, **forty feet wide**

alter and establish a County Road within said county, on the following line or route, to-wit: Commencing at the center of section 22 in T.2 S.R.39 E.W.M. at a point in the middle of the present county road, thence south one mile to a point at the middle of the present county road at the center of section 27 in said township and range, and there terminate; Also to lay out and establish a County Road forty feet wide within said county, on the following line or route, to-wit: Commencing at a point in the middle of the present county road at the S.E. corner of the S.W.  $\frac{1}{4}$  Sec. 23 in said township and range, thence south  $\frac{1}{4}$  mile to the middle of the present county road at the center of section 26 in said township and range, and there terminate;

We also petition your honorable body to vacate that certain portion of the present county road of Union County, within said county and described as follows:- Commencing at a point in the county road 19 rods north of the north east corner of the S.E.  $\frac{1}{4}$  of the S.W.  $\frac{1}{4}$  Sec. 22, T.2 S.R.39 E.W.M., thence in a general southeasterly direction to the S.E. corner of said section 22, thence south  $\frac{1}{4}$  mile to the north side of the present county road at a point 30 feet north of the north-east corner of the south-east quarter of section 27 in said township and range, and there terminate.

You, and each of you, will take notice that the undersigned FREEHOLDERS OF UNION COUNTY, OREGON, residing in the road district where the hereinafter described road is proposed to be, will, at the next term of the County Court of Union County, Oregon, to-wit: on Wednesday, the 4th day of February, A.D. 1908, respectfully present to said court a petition praying said court to lay out and establish a county road forty feet wide, within said County, on the following line or route, to-wit:

Commencing at the center of section 22 in township 2 south, of range 39 E.W.M. in the middle of the present county road, thence south one mile to the middle of the county road at the center of section 27 in said township and range, and there terminate;

Also to lay out and establish a county road forty feet wide within said county, on the following line or route, to-wit: Commencing at a point in the middle of the present county road at the south-east corner of the south-west quarter of section 23 in said township and range, thence south 1/2 mile to the middle of the county road at the center of section 26 in said township and range and there terminate;



Comes now W.R.Jasper, one of the petitioners for the above named proposed County Road, and presents to the Court the petition of himself and others, praying for the location and establishment of a county road, described as follows, to-wit:

Commencing at the center of Sec. 22, in Tp. 2 S. R. 39, E.W.M. at a point in the middle of the present County Road, thence south one mile to a point in the middle of the present County Road at the center of Sec. 27 in said township and range and there terminate. Also to lay out and establish a County Road 40 feet wide within said County on the following line, to-wit: Commencing at a point in the middle of the present County Road at the S.E. corner of the S.W. 1/4 Sec. 23, in said township and range, thence south 1/2 mile to the middle of the present County Road at the center of Sec. 26 in said township and range and there to terminate. And also for the vacation of that certain portion of the present County Road within said County and described as follows: Commencing at a point in the County Road 19 rods north of the N.E. corner of the S.E. 1/4 of the S.W. 1/4 Sec. 22, T/ 2 S. R. 39, E.W.M., thence in a general south-easterly direction to the S.E. corner of said Sec. 22, thence south 1/2 mile to the north side of the present County Road at a point 30 feet north of the N.E. corner of the S.E. 1/4 of Sec. 27 in said township and range and there to terminate.

# REPORT OF BOARD OF COUNTY ROAD VIEWERS.

To the Honorable County Court for Union County, Oregon :

The undersigned Board of County Road Viewers, heretofore on the 4th day of March 1908, instructed to view, lay out and alter the proposed county road, of which the survey hereto attached is a true and correct description, as petitioned for by W. R. Jasper et al., beg leave to report that on the 18 day of March 1908, in pursuance with said order, we proceeded to view out said proposed road for the whole distance thereof, and that in our opinions said proposed road should be laid out and established as a public highway of Union County, Oregon; that the same is practicable and would add \_\_\_\_\_ to the convenience of the householders residing in the vicinity thereof. We therefore recommend that said proposed road be \_\_\_\_\_ laid out and declared a public highway of said county and that they vacate the old road as petitioned for, and there is no claim for damages upon the change of said road

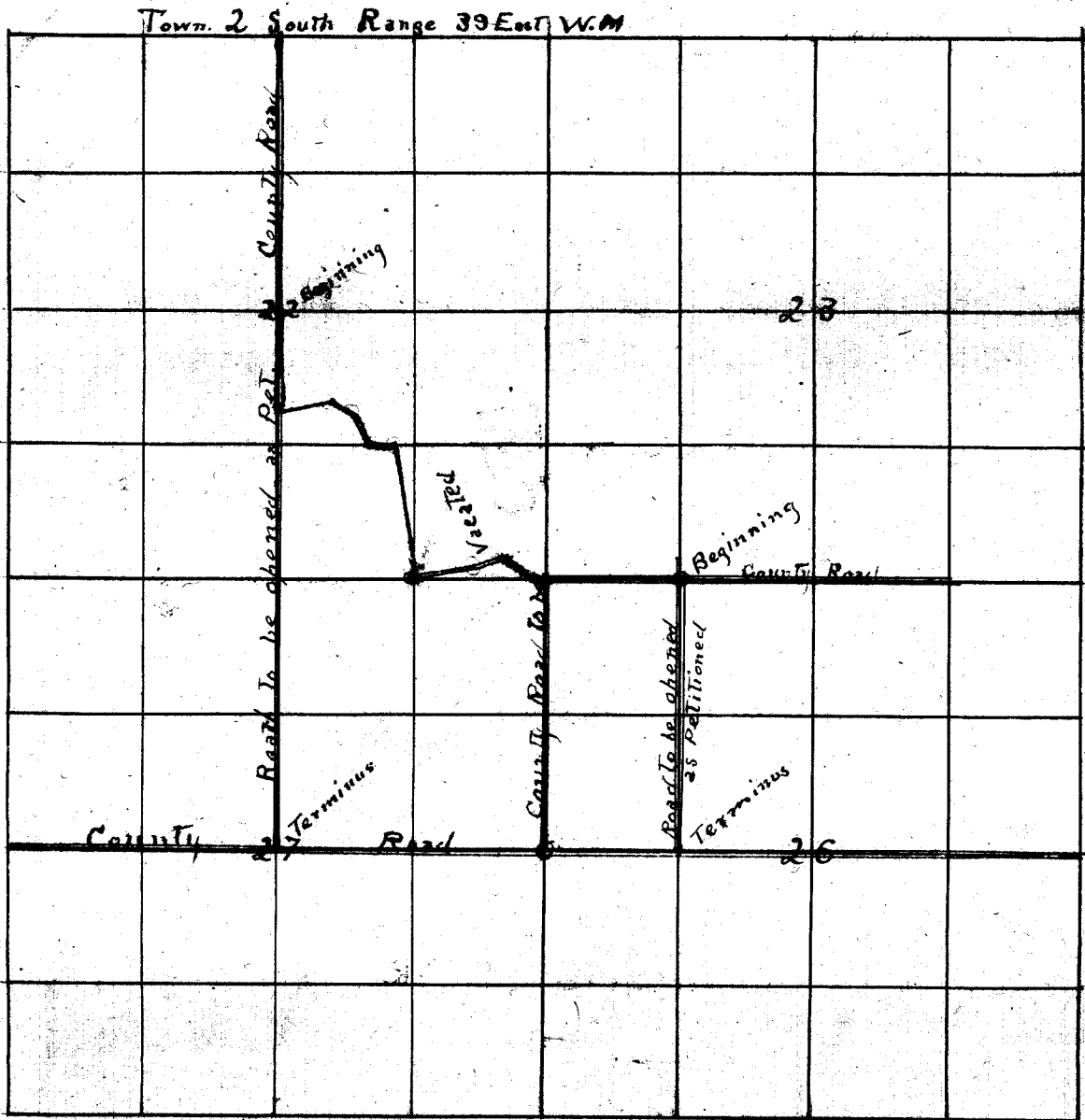
To the Hon. County Court of Union County, Oregon:

I, the undersigned, County Surveyor, appointed to survey the county road proposed by W. R. Jasper et al., beg leave to report that on the 18<sup>th</sup> day of March 1908 ~~189~~, in pursuance of said appointment and order, I Surveyed said proposed road for the whole distance thereof, the following being the field notes of said survey:

Commencing at the center of Sec. 22 T. 2 S. R. 39 E. W. M. Then South 80 Chains to center Sec. 27 said Town and Range and their terminus marked post on side of present County Road E-W. also (Commencing at a point in middle of County Road at the S.E. Cor. of the S.W. 1/4 Sec. 23 Town 2 S. R. 39 E. W. M.
