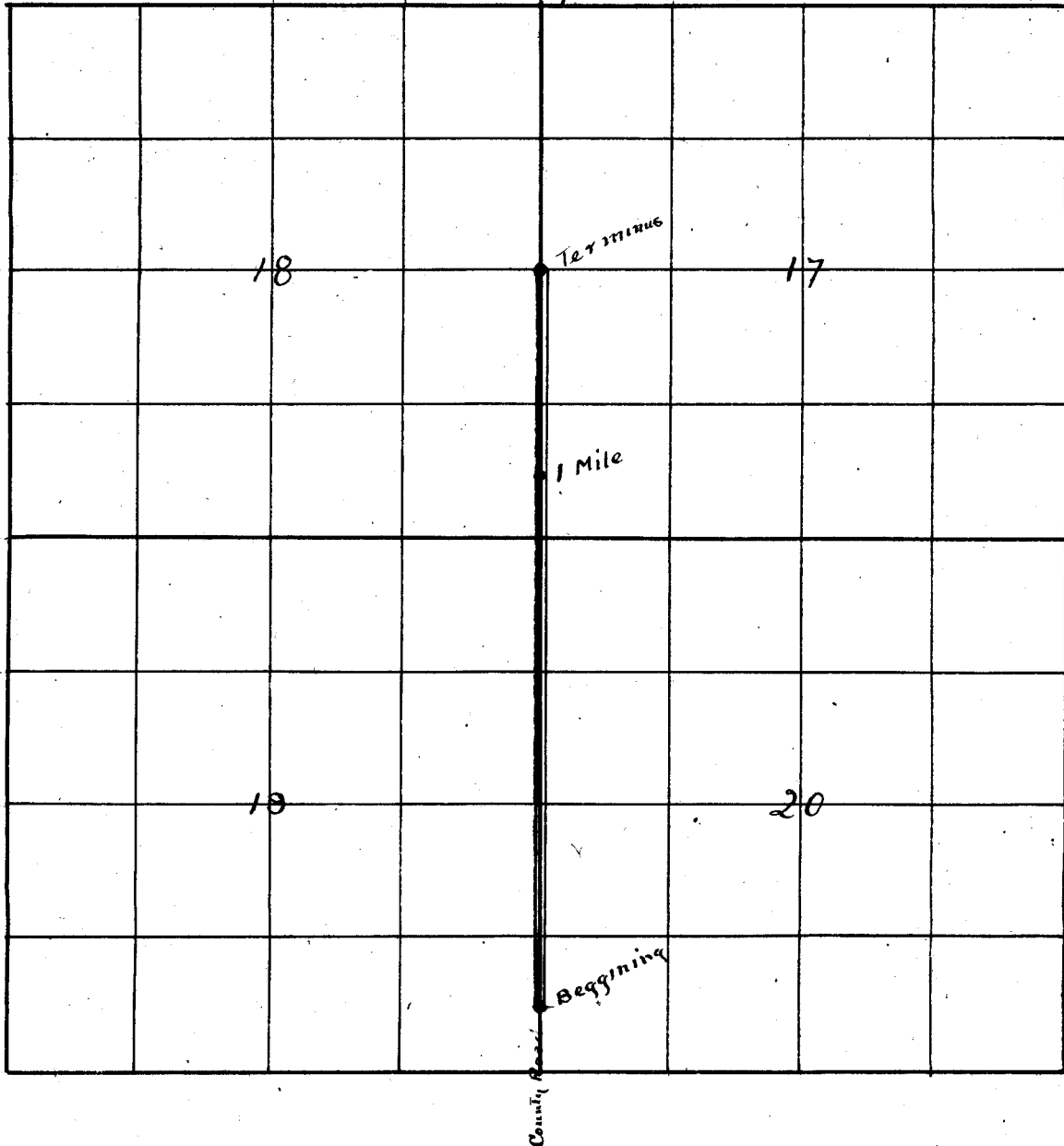

It is therefore ORDERED by the Court that Mrs. F. S. Ivanhoe be, and she is hereby appointed Hostess at the Oregon building on Union County Day at the Alaska-Yukon-Pacific Exposition.

In the Matter of the Appointment of Two Members of the Board of Commissioners of the First Eastern Oregon Agricultural Society for the ensuing two years.

Now at this time this matter came on for consideration of the Court in compliance with an Act of the Legislative Assembly of the State of Oregon, filed in the office of the Secretary of State, February 11, 1905, entitled, An Act "to provide for the establishment
