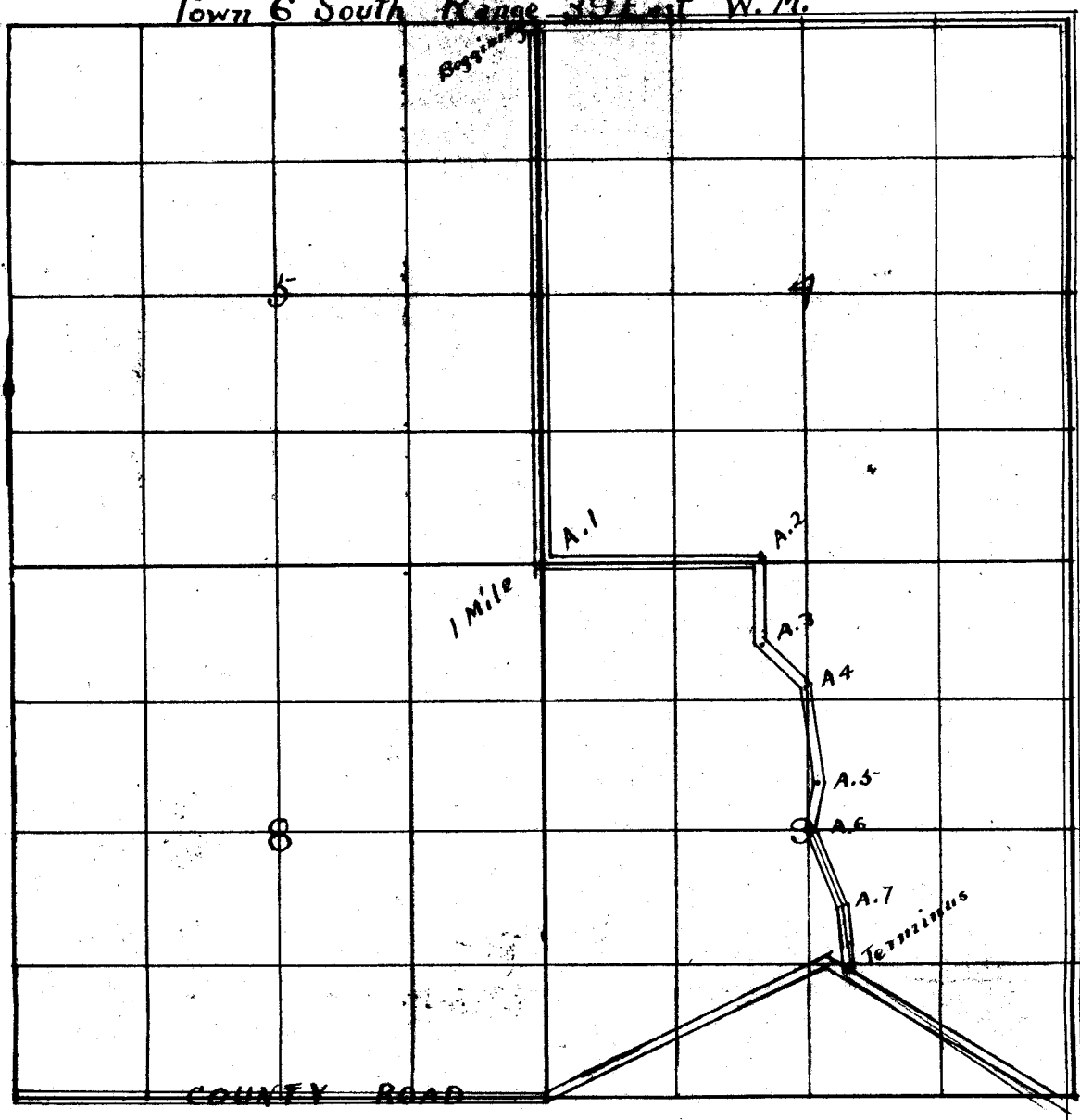

SECOND JUDICIAL DAY.

THURSDAY, DECEMBER 8th, 1910.

Sheriff of said county posted all of said notices, five in each of the twenty two precincts, at least twelve days prior to the election to be held in Union County, on the 8th day of November, 1910, to-wit: between the 15th day of October, 1910, and the 26th day of October, 1910, exclusive, and that each of said notices were posted in the vicinity of the polling place of each of the twenty two precincts, and that said County Clerk and Sheriff have entered of record their compliance with the provisions of this law contained in said Chapter 2.

That an election was held to determine whether intoxicating liquors shall be sold in Union County, Oregon, on Tuesday, the 8th day of November, 1910, the same being also the General Election of this State, and at said election there were case 1158 legal votes for the prohibition of the sale of intoxicating liquors in Union County, Oregon, and 1620 legal votes against such prohibition, thereby giving a majority of 462 votes against prohibition; and that thereafter on the 12th day of November, 1910, the County Clerk of said county, taking to his assistance two Justices of the Peace of said county, made an abstract of said votes finding the aforesaid results; and it appearing that all of the provisions of the Local Option laws have been complied with in the proceedings connected with said election,

It is therefore ORDERED that there were in said election on the 8th day of November, 1910, 1158 votes cast in favor of and 1620 votes against prohibiting the sale of intoxicating liquors in Union County, Oregon, and that there is a majority of 462 votes against said prohibition.

It is therefore further ORDERED that the order of this court heretofore made and entered herein on the 29th day of June, A.D. 1908, declaring the result of an election held in said county and state on the 1st day of June, A.D. 1908, to determine whether the sale of intoxicating liquors should be prohibited in Union County, Oregon, be and the same is in all respects rescinded, revoked and held to be null and void from and after this date.

And it is further ORDERED that the boundaries of the road district affected by the above change be reformed to correspond thereto.

In the Matter of the Petition of W.T. Stein et al for a change in the boundaries of Road Districts No. 21 and 23.

This matter came on to be heard at this time upon the petition of W. T. Stein et al for a change in the boundaries of Road Districts No. 13 and 21. And it appearing to the court from said petition that such change should be made,

It is therefore CONSIDERED and ORDERED that the line between Road Districts No. 13 and 21 be established as follows, to-wit: Commencing at the east boundary of the corporate limits of the City of La Grande, to-wit: The NW corner of the SE 1/4 of the SE 1/4 Sec. 5, Tp. 3 S. R. 38 E., thence east along said line to the intersection of Section 1 at the NW corner of the SW 1/4 of the SW 1/4 of said Sec. 1 said township and range.

In the Matter of the Proposed County Road Petitioned for by John Shaw et al.

This matter came to be heard at this time on the report of the Board of County Road Viewers for a second reading, as provided by law, said report being in words following to-wit:

REPORT OF BOARD OF COUNTY ROAD VIEWERS.

TO THE HONORABLE COUNTY COURT OF UNION COUNTY, OREGON:

The undersigned Board of County Road Viewers heretofore on the 7th day of Dec. 1910, instructed to view, lay out and later the proposed county road, of which the survey

hereto attached is a true and correct description, as petitioned for by John Shaw et al., beg leave to report that on the 14 day of Dec. 1910, in pursuance with said order, we proceeded to view out said proposed road for the whole distance thereof, and that in our opinions said proposed road should be laid out and established as a public highway of Union County, Oregon; that the same is practicable and would add greatly to the convenience of the householders residing in the vicinity thereof. We therefore recommend that said proposed road be laid out and declared a public highway of said county and that by location of same John Brant will be damaged to the amount \$85.00 (Eighty five dollars)

And said report of the Board of County Road Viewers having been now publicly read in open court on two several days of the present term of the court, and it appearing to the Court that said Board of County Road Viewers report favorably thereon, and recommend that said proposed road be established as a county road and be declared a public highway of Union County, Oregon, and all the proceedings herein having been regular and according to law, and no remonstrance or claim for damages having been filed herein except that the Board of County Road Viewers report that John Brant will be damaged to the extent of \$85.00 by the location of said road, and there having been no cause shown why this proposed road should not be declared a public highway and ordered open according to law, and the court being satisfied from the report of the Board of County Road Viewers that such road will be of public utility; the report of the viewers being favorable thereto, and all the files and records of said proceedings having been submitted to the District Attorney, who has advised this court as to the legality of said proceedings,

It is therefore CONSIDERED and ORDERED by the Court that the report of the Board of County Road Viewers be placed on record in this journal, and that the surveyor's profile and plat of the proposed road, and his field-notes of the survey thereof be placed on record in the Book of Plats of County Roads of Union County, Oregon, and that said proposed road be declared a public highway of Union County, Oregon, and ordered opened up and placed in repair for travel according to law, and that Road Supervisor of Road District No. 29, the same being the road district in which said road is located, be furnished with a copy of the petition herein, and a copy of this decree and ordered to open up said road and place the same in repair for travel, upon the payment by the petitioners the amount of the damages assessed by the Board of County Road Viewers.
