TO THE HONORABLE COUNTY COURT, FOR UNION COUNTY, OREGON:

The undersigned freeholders, of Union county, Oregon, residing in the road district where the hereinafter described road is proposed to be, respectfully petition your Honorable body to lay out, ~~alter~~ and establish

a County Road ^{50 feet wide} within said county, on the following line, or route, to-wit:

Commencing at the NE corner of section 10 T2SR38E1N7 and running thence East $\frac{3}{4}$ of a mile to intersect the present County road at the SE corner of the NW $\frac{1}{4}$ of the E $\frac{1}{4}$ of Sec 11 T2SR38E1N7, and there terminate. And to vacate the following described portion of the present County road to-wit: Commencing at the SE corner of NW $\frac{1}{4}$ of E $\frac{1}{4}$ Sec 11 T2SR38E1N7 thence South $\frac{1}{4}$ mile, thence West $\frac{3}{4}$ of a mile, to the intersection of the County road on the Western line between Sections 14 and 15 in said township.

We, the undersigned do hereby remonstrate against the granting of the road petitioned for by, John Blockland, Hermann Verhs, John Speckhart, D. McDonald, P.A. McDonald, J.L. Feek, G.W. Evans, W.W. Barney, John Shaw, H.A. Canfield, J.S. Perry, J.D. Black, James Ainsworth, Robert Leak, J.A. Leak, H.S. Hendricks, J.R. Beddes and J.S. Mitchell, for the reasons that there is already a well established county road that serves the needs of the above petitioners, that all of the petitioners are not residents of the road district, in which the said proposed road is situated, to-wit, John Blockland, P.A. McDonald and D. McDonald. That petitioners John Blockland by the establishment of the said proposed road, would gain thirty feet of land and John Speckhart would gain thirty feet of land for the distance of his farm, so that the said road is inspired for purposes of gain, rather than a public benefit. That the damage to the undersigned lands, would be far greater than any benefit that could accrue to the petitioners (other than Blockland and Speckhart) or the public in general.

WHEN, on Thursday, the 2nd day of November, A. D., 1901, or the 2nd Judicial Day of said term, among others the following proceedings were had, to-wit:

In the matter of the proposed county road petitioned for by John Blokland et al.

This matter came on to be heard at this time on the petition of John Blokland et al for the establishment of a county road upon the following lines: Commencing at the S.E. corner of Sec. 10, Tp. 2 S. R. 38, and running thence east $\frac{3}{4}$ miles to the intersection of the present county road at the S.E. corner of the SW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Sec. 11, Tp. 2 S. R. 38 and there terminating, and to vacate the following described portion of the present county road: Commencing at the SE corner of the SW $\frac{1}{4}$ of the SE $\frac{1}{4}$ of Sec. 11, Tp. 2 S. R. 38 E. thence south $\frac{1}{4}$ mile, thence west $\frac{1}{4}$ mile, to the intersection of the county road on the section line between Sections 14 and 15 in said township. And it appearing to the court that a remonstrance has been filed against the establishment of said proposed road and said vacation of a county road, and that the signers of the remonstrance outnumber the signers on the petition to a considerable extent,

It is therefore CONSIDERED and ORDERED that said petition be and the same is hereby denied.
