Now at this time this matter came on for final hearing upon the Report of the County Surveyor, and it appearing to the court that the County Surveyor has filed in writing his report in which he recommends that the petition be granted and that a plat of the road be filed and the old road vacated as petitioned for.

It is therefore CONSIDERED and ORDERED that said petition be granted and that said proposed road petitioned for along the following route, to-wit: Commencing at a point where the county road crosses the railroad logging grade of the Palmer Lumber Company, at the Palmer Lumber Camp No. 1, thence following said railroad grade in an easterly direction to a point about one-fourth of a mile south of Palmer Junction, Oregon, where said grade intersects with county road on the west side of the Grande Ronde River (grade intersecting with proposed county road being built from north end of Cricket Flat) and vacating at present the county road extending from Palmer Lumber Company's Camp No. 1 to Palmer Junction, Oregon, be and the same is hereby established as a county road and ordered placed in repair for travel, and the old road declared to be vacated.
