signed by the petitioners, and that a bond for the cost of this proceeding has been duly given.

It is therefore ORDERED that Roscoe Neal, County Surveyor, and F. D. Gaskill and L. H. Russell, constituting the Board of County Road Viewers be, and they are hereby directed to meet at Hilgard, Oregon, on the 28th day of March, 1919, at the hour of 9 o'clock A. M., or within five days thereafter and proceed to survey, view and lay out said road according to law.

In the matter of the establishment of a County Road on the North side of the tracks of the O.W.R.& N.Co. in the vicinity of Hot Lake.

WHEREAS it appears to the County Court of Union County, Oregon that the establishment of a County Road along the following lines, towit: Beginning at the 4 section corner between sections 4 & 5 in Tp. 4, S. R. 59 E., and running thence West past the Albers Warehouse to and across the 0.W.R.R.& N.Right-of-way to intersect the present highway, would be of material benefit to persons residing in the vicinity of said proposed road and would connect with the State Highway running through Union County,

THEREFORE BE IT RESOLVED that such proceedings be taken as are required by law to establish a County Road as above described.

BE IT FURTHER RESOLVED that duly certified copies of this resolution be posted in the manner and for the time required by law, and the hearing of this resolution be set for the 7" day of May 1919, at 10 A. M.

In the matter of the vacation of a portion of the Foot Hill Road in the vicinity of Hot Lake.

WHEREAS it appears to the County Court of Union County, Oregon that a portion of the Foot Hill Road in the vicinity of Hot Lake described as follows:— Beginning at a point approximately one fourth mile East of the SW corner of the SW, of the NE, of Section 6, in Township 4, S. R. 39 E.W.M., and running thence Southeasterly along the foot hill road and South of the Hot Lake Sanatarium to a point S. 55 deg. E. approximately 1715 feet from the W.W. corner of the S.E., of Section 5 in said Tp. 4, S. R. 39 East of the W. M., all of which lies in the S. $\frac{1}{2}$  of said Sections 5 & 6 in said Tp. 4, S. R. 39 E., is useless as a part of the general road system of Union County, and is burdensome to maintain, and

WHEREAS, the traveling public is amply served by another County road of a much better grade a short distance North of and running parallel to said road proposed to be vacated,

THEREFORE, BE IT RESOLVED that such proceedings be taken as are required by law to vacate said above described road.

Now at this time this matter came on to be heard upon the petition of Russell Chandler praying that a sum be granted him monthly as County Aid, and it appearing to the court from said petition that the said Russell Chandler is of the age of 73 years and his wife of the age of 72 years and that by reason of their advanced age and ill health, it is impossible for them to earn a livlihood; that they have no relatives who are able or willing to assist them, except a daughter who resides with them whose time is required at home; and it further appearing to the court that the said Russell Chandler is deserving and should have an allowance made to him.

It is therefore ORDERED that an allowance of \$20.00 per month be granted the said Russell Chandler until the further orders of this court and the Clerk is hereby authorized and directed to draw a warrant on the General Fund of the County in the sum of \$20.00 in his favor.

In the matter of the proposed County Road petitioned for by H. E. Hagey et al.

Now at this time it appearing to the court from the report of the Viewers heretofore appointed to view the above entitled road that they have been unable to complete their work on account of encountering large quanties of snow along the line of said proposed road,

In the matter of the proposed County Road petitioned for by H. E. Hagey et al.

This matter came to be heard at this time on the report of the Board of County Road Viewers, said report being in words following towit:

REPORT OF BOARD OF ROAD VIEWERS.

To the Honorable County Court, Union County, Oregon. Gentlemen:-

We, the undersigned Board of County Road Viewers, heretofore on the 6th day of March 1919, A. D. directed to view, survey, and lay out the proposed road as petitioned for by H. E. Hagey and others, beg leave to report that on the 29th day of April, 1919, in pursuance with said order, we proceeded to view out said road for the whole distance thereof, and that in our opinions said road is practicable and will be a general benefit to the public and should be laid out and declared a public highway, along the alighment as indicated in the petition.

We find that such road will damage no property and will be a benefit to the land adjacent thereto, but beg to recommend that fences be constructed on both sides of the road where it passes thru pastures which are now fenced and that a number of cattle passes be provided where needed in pastures which are now fenced.

And said report of the Board of County Road Viewers having been now publicly read in open court on two several days of the present term of the court, prior to this date, and it appearing to the court that said Board of County Road Viewers report favorably thereon, and recommend that said proposed road be established as a county road and be declared a public highway of Union County, Oregon, and all the proceedings herein having been regular and according to law, and no remonstrance or claim for damages having been filed herein, and there having been no cause shown why this proposed road should not be declared a public highway and ordered open according to law, and the court being satisfied from the report of the Board of County Road Viewers that such road will be of public utility; the report of the viewers being favorable thereto, and all the files and records of said proceedings having been submitted to the District Attorney, who has advised this court as to the legality of said proceedings,

It is therefore CONSIDERED and ORDERED by the court that the report of the Board of County Road Viewers be placed on record in this journal, and that the surveyor's profile and plat of the proposed road, and his field-notes of the survey thereof be placed on record in the Book of Plats of County Roads of Union County, Oregon, and that said proposed road be declared a public highway of Union County, Oregon, and ordered opened up and placed in repair for travel according to law.
