WHEREAS, The north 20 feet of said street has never been used as a street but has been occupied since the platting of said Additions by the respective owners of the land bordering on the north side of said street and a part of said 20 feet is occupied by buildings belonging to the owners of the land adjacent thereto; that said 20 feet of said street beginning immediately south of the east side of said Sunnyside Subdivision of Lots one to ten, Block two and Lots one to ten, Block three of Rynearson's Addition and running westward along the north side of said street to a point immediately south of the west side of Block 11 of said Rynearson's Addition and being of a uniform width of 20 feet is useless as a part of the general road system and is burdensome to maintain and that the public will be benefited by said strip of 20 feet being vacated and,

M. Kurtz is the owner of Lots 8 and 9 in

said Block 2 and M. E. Greenough is the owner of Lot 6, Block 2, Sunnyside Subdivision of Lots one to ten, Block two and Lots one to ten, Block three of Ryneerson's Addition and said owners have requested and are willing that said 20 feet of said Lake Avenue be vacated.

Now Therefore, be it resolved by the County Court of Union county, Oregon that said parties are the owners of the respective premises above described and are willing and have requested that the north 20 feet of said Lake Avenue beginning immediately south of the east side of said Sunnyside Subdivision of Lots one to ten, Block two and Lots one to ten, Block three of said Ryneerson's Addition and extending westward to the west side of Block 11, Ryneerson's Addition, be vacated; that said part of said street is useless as a part of the general road system and is burdensome to maintain and that the public will be benefited by its vacation and that proceedings to vacate said portion of said road will be undertaken.

For the Partial Vacation of Lake Street

I beg leave to report that on the 7th day of March, 1935, in pursuance with said order I proceeded to view out that portion of Lake Street in Rynearson's Addition described as follows and shown on the accompanying map:

Beginning at a point at the Southeast corner of Block 2 in Rynearson's Addition thence West along the South boundary lines of Blocks 2, 5, 8 and 11 to the Southwest corner of Block 11, thence South a distance of 20 feet, thence East a distance of 1199.5 feet, thence North a distance of 20 feet to the point of beginning, excepting the 80-ft. portion of the following streets which run North and South across the above described 20 ft. strip; First, Second and Third Streets.

Said strip is 20 feet in width and being on the North side of Lake Street.

The above described 20 feet is not used as a street and is burdensome to the county and is useless as a part of the general road system of the county. The remaining 60 feet of the street is adequate for all street purposes.

I, therefore, recommend that the said portion of Lake Street be closed as part of a public street of Union County, Oregon.

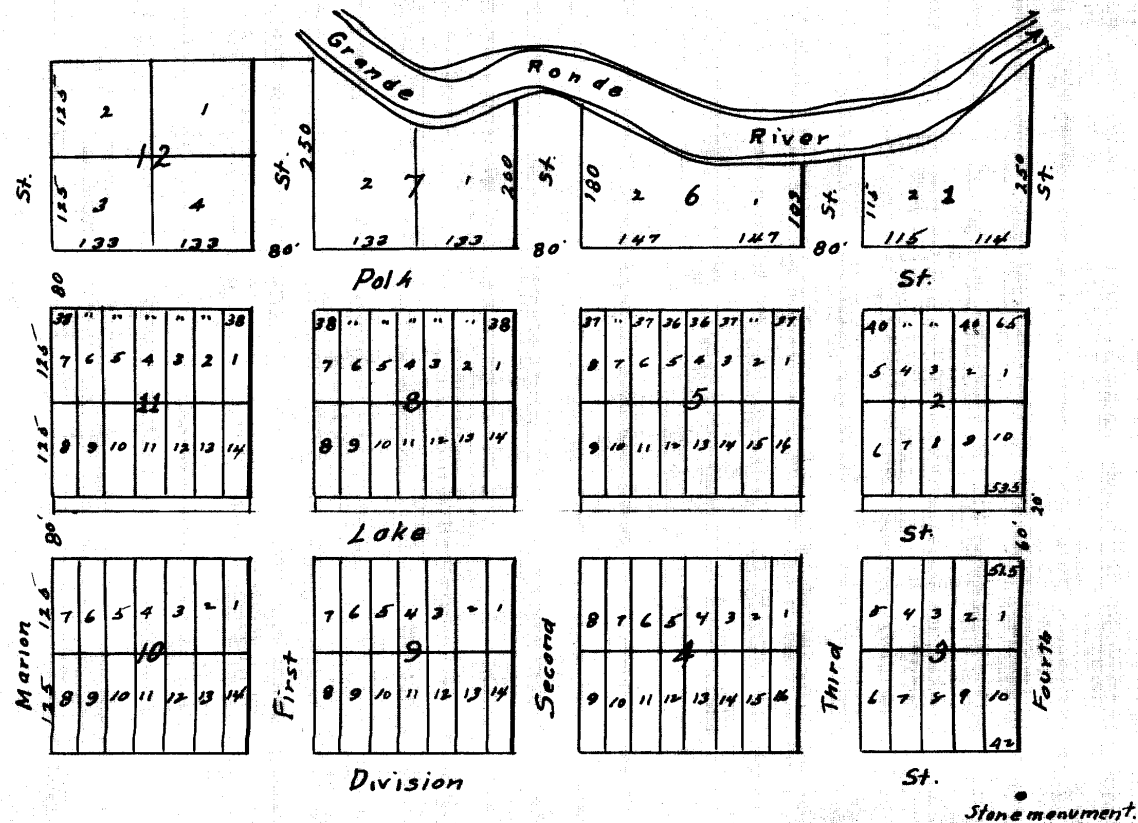
# RYNEARSON'S ADDITION

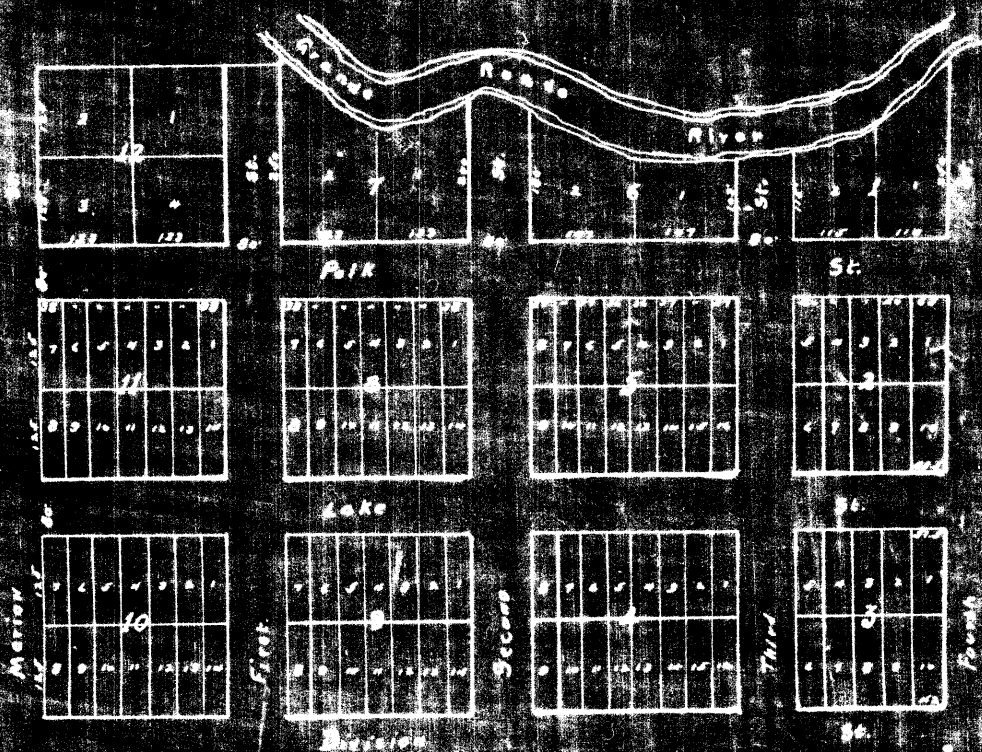
# RYNEARSON'S ADDITION




