We, the undersigned remonstrators, to the petition of Phillip Houghton, et al, for laying out a County Road, (Which road is to commence at the easterly end of the bridge across Main Powder River, known as the Houghton Bridge, situated on the Sturgill Ranch in Union Co Oregon, thence running in an easterly Course, and down Powder River, aforesaid, on the most practicable <sup>and nearest</sup> route to the Co road running from Sparta to Union, at a point near the Brown Ranch on Goose Creek, on said Co. 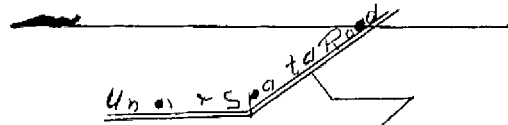

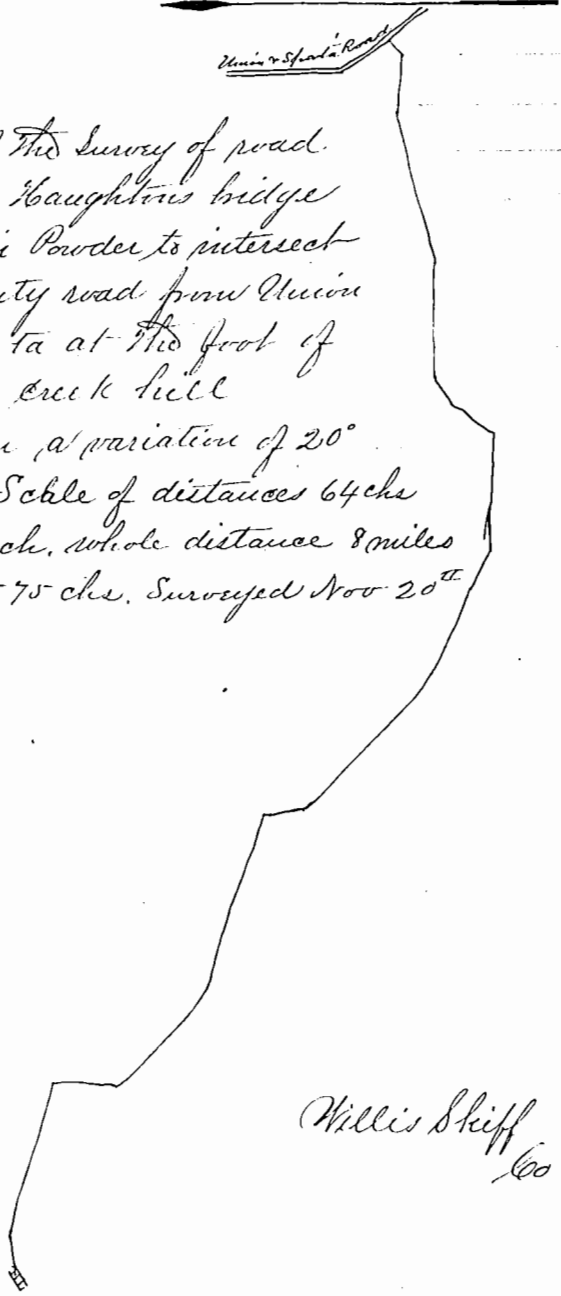
