

AND IT FURTHER APPEARING TO THE Court that the report of the Viewers is just and the damages assessed are adequate; NOW THEREFORE.

IT IS HEREBY ORDERED that the Report of the Viewers be, and the same is hereby confirmed, and that upon the payment by the petitioner of the damages assessed by the Viewers that said road as viewed and laid out in said Report, be and the same is hereby established as a public road, and that the same be recorded as such, and that petitioner shall have the right to go upon said roadway for the purpose of building the fences provided for in the Report of the Viewers, and that upon said fence being built the petitioner and the public shall have the right to travel said road without interference.

DATED this 5th day of November, 1953.

Thereupon it was ordered that court be now adjourned for the term, the journal of today's proceedings having been read, approved, and which is here now signed.
