Blackman, surveyor, being duly sworn, depose and say that I have surveyed, subdivided and platted CLEARWATER POND, situated in the Northwest Quarter of the Southwest Quarter of Section 34, Township 2 South, Range 38 East of the Willamette Merdian. More particularly described as follows:

Begining at a 2 1/2" x 36" galvanized iron pipe, with brass cap marked "INITIAL POINT + CLEARWATER POND SUBDIVISION", said point being 18.62 feet South and 1291.41 feet East of the West 1/4 corner of Section 34.
