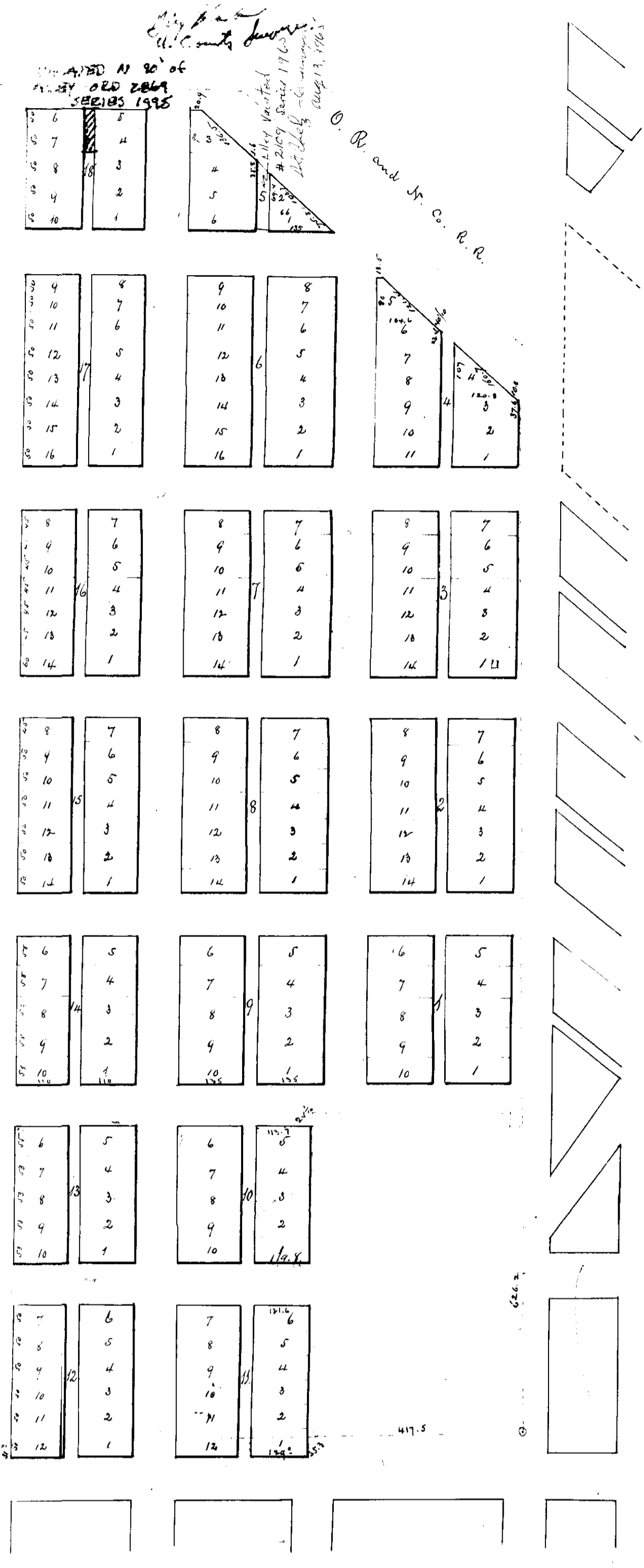

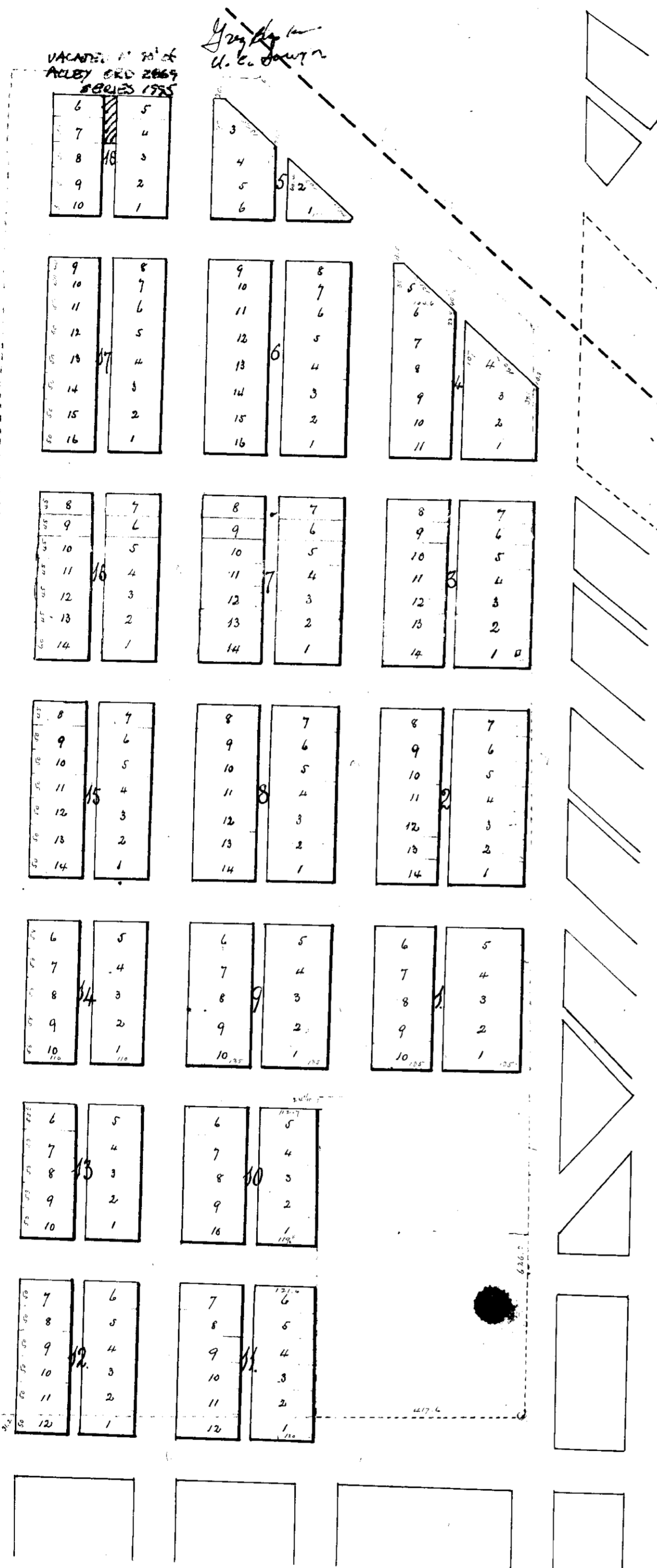

B. W. Grandy to The Town of LaGrande.

To all to whom these presents shall come, greeting: Know ye that I B. W. Grandy, having laid out an Addition to the Town of LaGrande, Union County, Oregon, and caused the same to be platted and said plat to be duly recorded in the Clerk's Office for said Union County in Book H page 539 of Records of Deeds of said County, but which record is defective in that said plat does not locate said Addition: Now therefore for the purpose of correcting the same I do hereby declare that the said Addition is located and described as follows: -

Commencing at a point six hundred twenty six and two-tenths (626.2) feet North from the South East corner of Section six (6) Township Three (3) South Range thirty eight (38) E. W. M. in Union County Oregon, thence four hundred and seventeen and five tenths (417.5) feet west thence six hundred and twenty six and two-tenths (626.2) feet south, thence six hundred and seventy six (676) feet west, thence twenty six hundred and forty feet north, thence five hundred feet East to the South side of the O. R. & N. Ry. Co. right of way, thence nearly south east following the line of said right of way a distance of about seven hundred and fifty feet to the intersection of a line running North from the point of Commencement. Said Addition being located on the East half of the South East quarter of Section six Township Three South Range thirty eight E. W. M. That all Streets and Alleys are as indicated on said plat and I hereby dedicate all of said Streets and Alleys to public use for ever. That all lots and blocks are of the size as marked and shown on said Plat. The said Plat being drawn to a scale of 200 feet to one Inch.
