

MAP OF SIXTH ADDITION TO ISLAND CITY CEMETERY

I, James G. Voelz, certify that I am a registered land surveyor in the State of Oregon and have surveyed the land as shown on accompanying plat. The initial point of the survey is designated by a two inch galvanized pipe thirty six inches long and driven six inches below surface of ground. Beginning at a point N 0° 04' E 1438.4' and S 89° 54' E 32.25' from one quarter section corner common to sections 3 and 10, T-3-S; R-38-EWM. This above described point being the SW corner of Sixth Addition to Island City Cemetery and point of beginning description of said addition. Thence N 0° 04' E 120'; Thence S 89° 54' E 463.95'; Thence S 46° 10' E 173.58' to the NE corner of Fifth Addition to Island City Cemetery. Thence N 89° 54' W 589.23' to point of beginning.

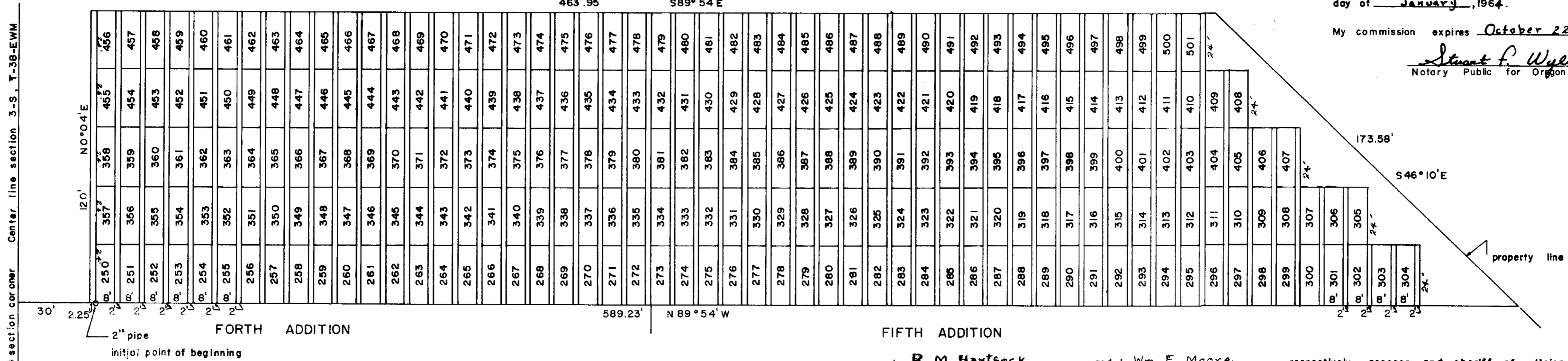

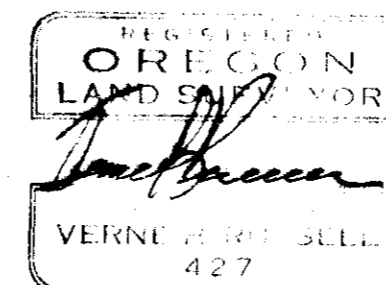
