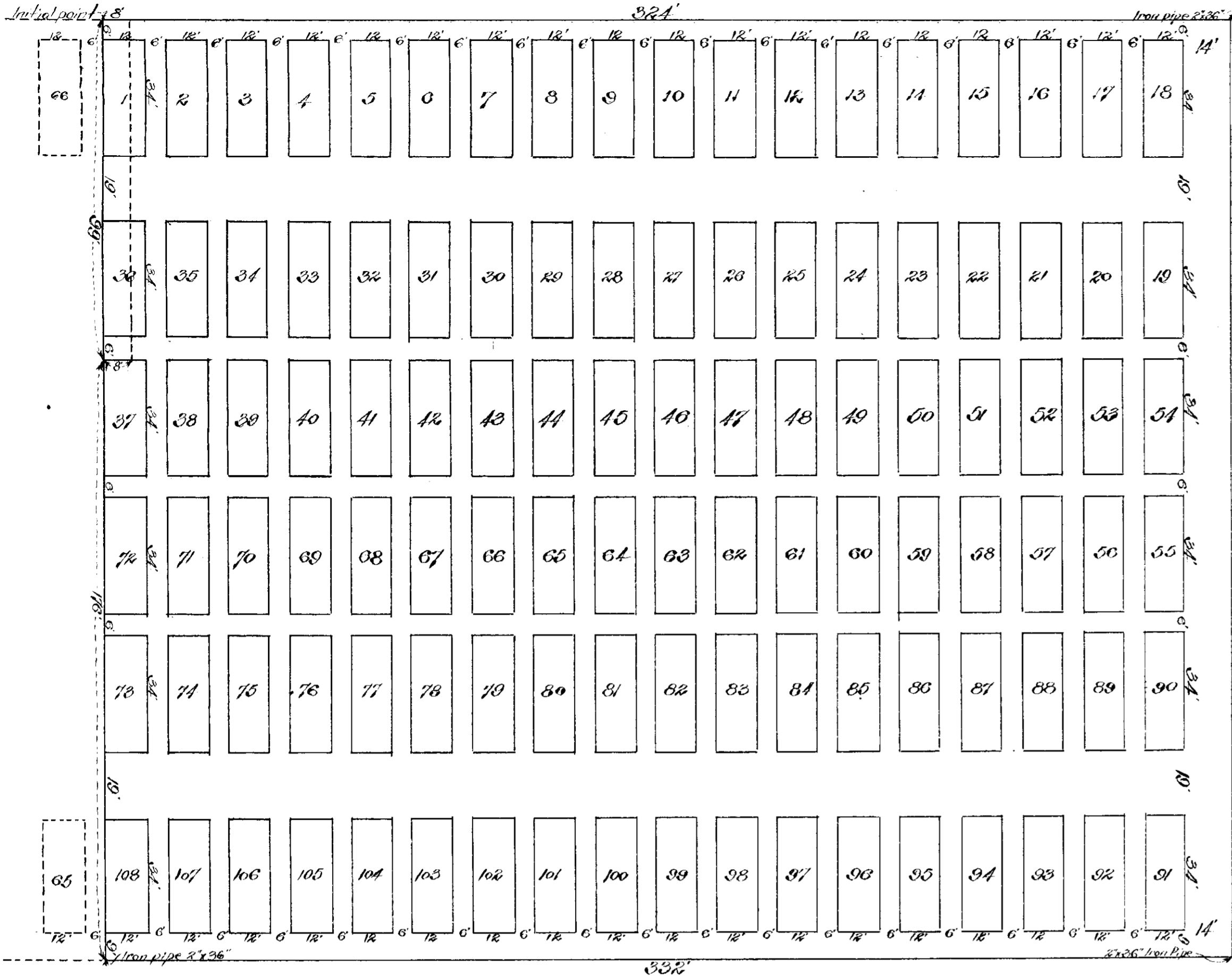

Know All Men By These Presents: That we the Island City Cemetery Association of Union County Oregon owner of the land shown on this plat, have caused the same to be sub-divided into lots, streets and alleys, of the size, shape and dimensions as indicated by the words, lines and figures shown upon this plat, and that the alleys and streets, are hereby set aside and dedicated to the public for perpetual use, and that this sub-division shall here after be known as and is hereby designated as the Third Addition to Island City Cemetery.

Certificate of Surveyor.

I, Roscoe Neal, of La Grande, Oregon, do hereby certify that I am a registered professional Civil Engineer, and that on Sept. 1<sup>st</sup> 1925 I personally surveyed and sub-divided the Third Addition to Island City Cemetery, in Union County, Oregon, and that the boundary of the land so sub-divided is described as follows:-

Beginning at the initial point of this survey, which is a galvanized iron pipe two inches in diameter and thirty six inches long, driven six inches below the surface of the ground and located 344 feet East of the N.W. corner of the S.W. 1/4 of the SE. 1/4 of Sec. 3 in Tp. 3 S. R. 38 E. of N.M. in Oregon, and running thence East 332 feet; thence South 275 feet; thence West 332 feet; thence North 275 feet to the place of beginning.
