

## SURVEYOR'S CERTIFICATE

I, GREGORY T. BLACKMAN, surveyor, being duly sworn, depose and say that I have surveyed, subdivided and platted LANKFORD'S SUBDIVISION PHASE II, a replat of lot 5, block 'A' of LANKFORD'S SUBDIVISION PHASE I, more particularly described as follows:

Beginning at the northwest corner of lot 5, block A LANKFORD'S SUBDIVISION PHASE I, said point being south a distance of 141.99 feet, and East a distance of 2.03 feet of a 2"x 36" iron pipe with brass cap marked "LANKFORD'S SUBDIVISION + INITIAL POINT" said pipe being 39.97 feet South and 329.36 feet West of the East 1/16 corner of the North line of Section 6, T3S, R38E, W.M.;

Thence S 0° 49' 10" E , 340.83 feet;

Thence S 89° 59' 45" E, 288.96 feet, to the west R/W line of UNION PACIFIC RAILROAD spur line; Thence 105.91 feet along a curve to the Left of a radius of 621.62 feet, the long chord of which bears N 11° 22' 02" E, 105.78 feet;
