



#### NARRATIVE

This subdivision was completed at the request of Edward and Irene Robertson for the purpose of dividing their property for future sale. I base the exterior of this subdivision on Survey Number 018–1985 which located the Lots of May Park. I found the monuments along the South line of Lot 4 and within Lot 5 of said May Park as set by said survey and accept the positions. This subdivision was originally approved by the Union County Planning Commission in April of 2000, with a special clause that he could keep the approval open with an annual letter requesting an extention. Mr. Robertson kept the approval urrent, and now wishes to perfect the application. There is an existing house on Lot Number 1, and an existing trailer house located on Lot 4, Lots 2 and 3 are vacant land. I create the lots at the direction of the Robertsons. I use the found monuments at the Southwest and Southeast Corners of said Lot 4, and monument the Northwest and Northeast corners using the calls documented in Survey Number 018–1985. I find the existing conditions to be very harmonious with the monumentation. I find no unusual conditions with this survey.
