

McC. Daniels Addition to the town of Love Union Co. Oregon
as surveyed by me is as follows: That part of the East half
of the South East 1/4 of Sec 16 Township 3 South of Range 40 East
of the Will. Mts. commencing at the South West corner running
North 40.28 chains, thence East 397 feet, thence South 39.25 chains
thence East 109 feet, thence South 69 feet to intersection of sec. line
thence West 501 feet to place of beginning. Main & Orchard Sts
are each 60 feet wide, Mill St. is 30 feet wide, Foster, Laddie,
Alder, Poplar, Elm, & Ash Streets are each 40 feet wide.
Lots 1, 2, 3, 4 are 40 x 69 feet, Lot 5 40 x 100 feet. Lot 6 East line is
100, West line 97 feet by 40 feet wide. Lot 7 East line 97 West line
94 feet by 40 feet wide. Lots 8, 9, 10, + 11 are each 120 x 120 feet.
Blocks A, B, C, D, + E, the lots are 150 feet North + South and 151
feet East + West. Block F, the lots are 165 feet North + South + 151
feet East + West.





