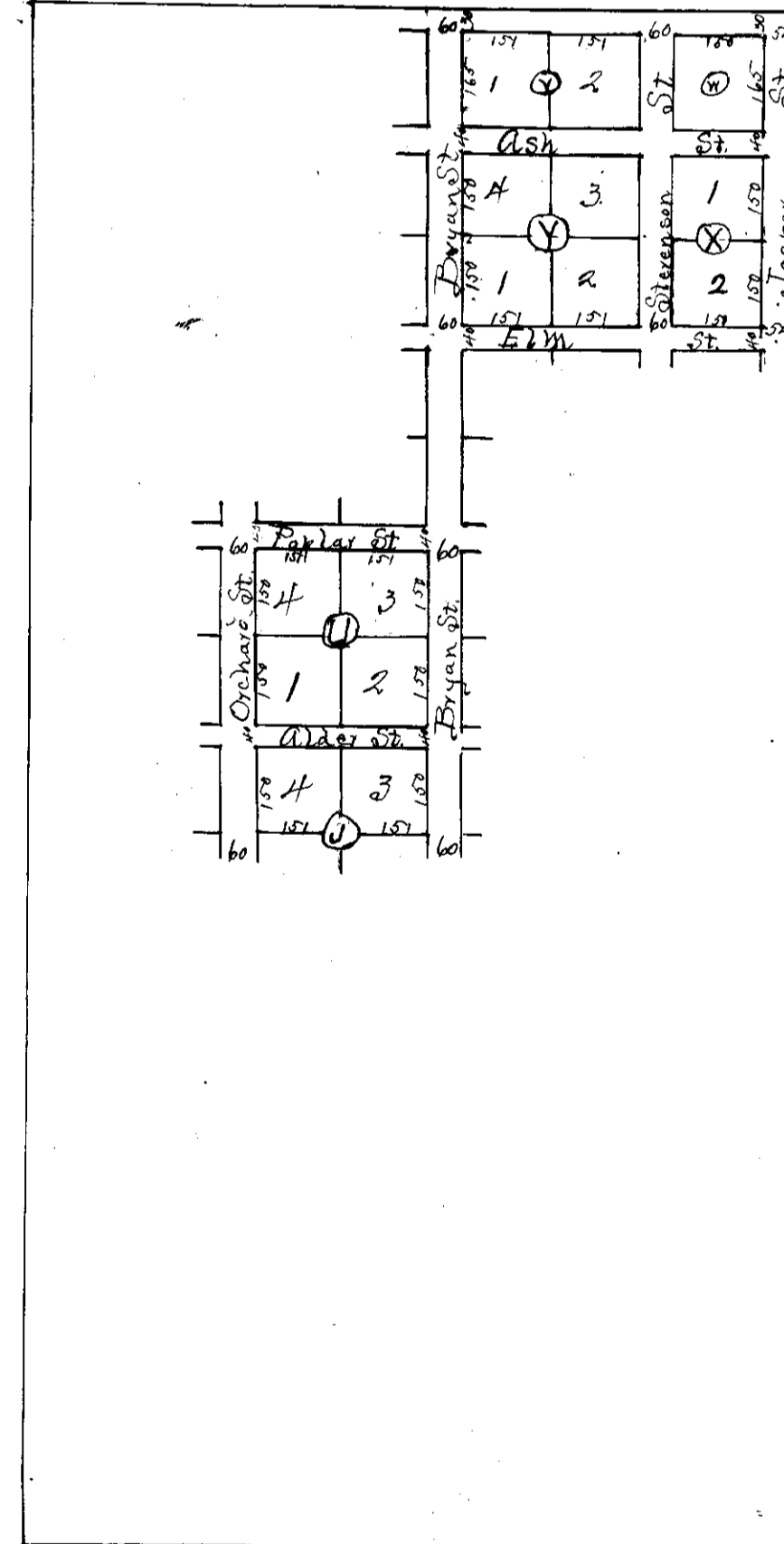

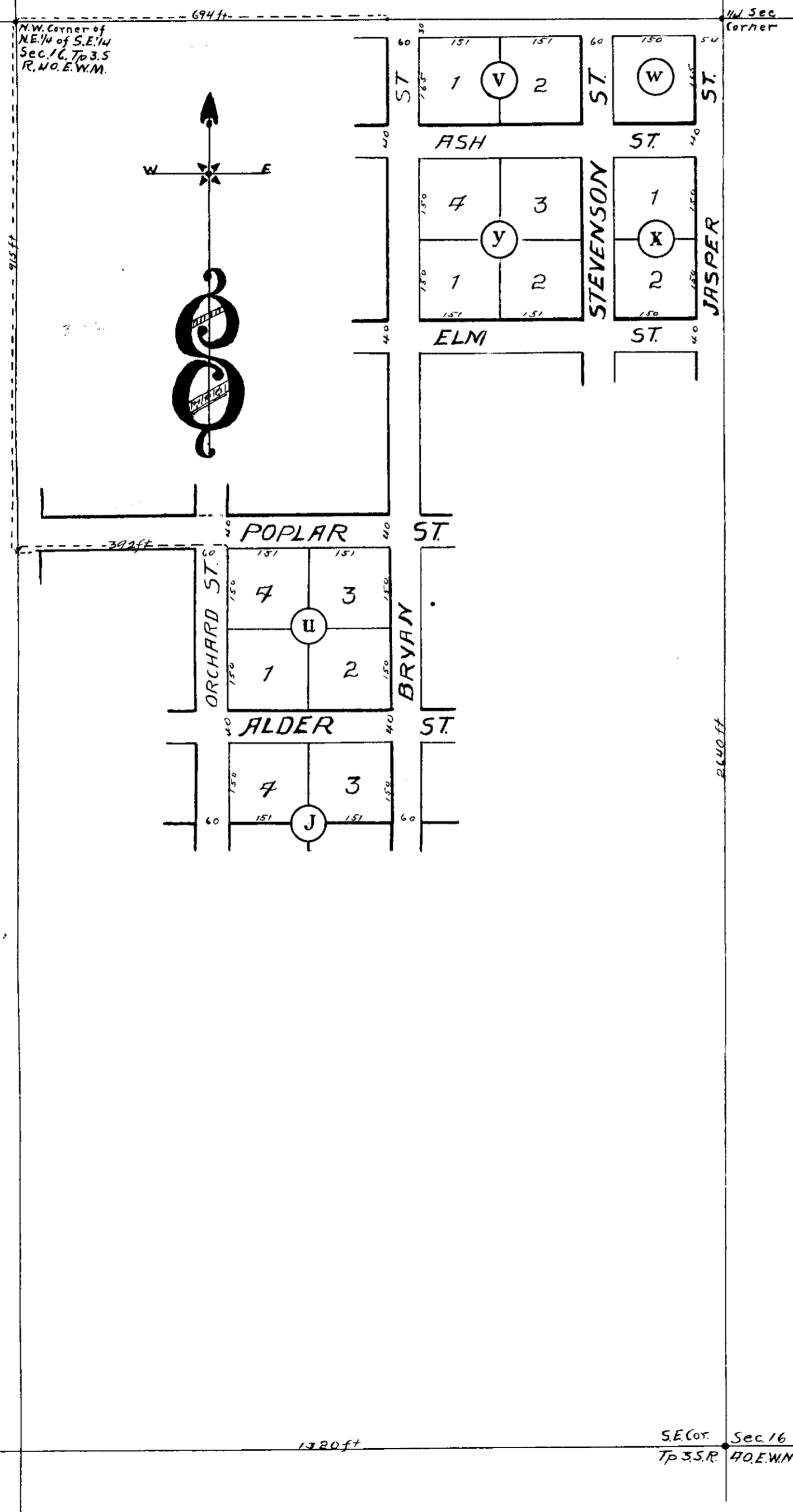

S. R. 40. E. W.M. thence East 626 feet, thence South 535 feet, thence West 626 feet, thence North 535 feet to place of beginning; Also Commencing at a point 915 feet South and 392 feet East of the N.W. corner of N.E. 1/4 of S.E. 1/4, Sec. 16, T. 3. S. R. 40. E. W.M. thence East 302 feet, thence South 490 feet, thence West 302 feet, thence North 490 feet to the place of beginning. That the measurements of all Lots, blocks, and streets are as shown on said plat, and the streets shown thereon are hereby dedicated to the public use forever.
