



PARK ADDITION TO LA GRANDE, ORE.

Situate on the N 1/2 of the N.E. 1/4 of Section 5, in Township 3, S.R. 38, E.

DEDICATION.
KNOW ALL MEN BY THESE PRESENTS, That the Amalgamated Sugar Company, a corporation, owner of the land platted and described upon the above foregoing map, being a part of Section 5, Township 3 South, Range 38 East of Willamette Meridian, more particularly described as follows: Commencing at the N.W. corner of the N.E. 1/4 of said Section 5, thence South 1310 feet to a point in the center of North Spruce Street due west of the north line of I Avenue; thence East along the north line of said I Avenue 1325 feet; thence North 30 feet; thence East 1320 feet to the east line of said Section 5; thence North 127 feet to a point 35 feet south of the N.E. corner of Sec. 5; thence West 1297 feet; thence North 33 feet to the north line of said Section 5; thence West 747.5 feet, more or less, to the point of beginning. Excepting from the above described tract, a strip of land 40 feet in width, being 20 feet in width on each side of and parallel with the following described line, to-wit: Commencing at a point 927 feet west and 162 feet south of the N.E. corner of Sec. 5, thence South, R38 E W1/4, running thence South 465.50 feet; thence East 430 feet; thence South 65.31 feet; thence East 200.0 feet; thence East 211.8 feet to a point 626.8 feet South and 20 feet west of the N.E. corner of said Sec. 5; thence South, parallel with said section line 643.2 feet to the south line of the tract first above described. Said 20-foot strip of land being used for irrigation ditch purposes. Said tract of land to be hereafter known as Park Addition to La Grande, Ore. And said Amalgamated Sugar Company does hereby dedicate to public use forever all rights and interests in and to the tract of land hereabove described and marked on said plat as streets.
