RESTRICTIVE COVENANTS

- I. No lot shall be used except for residential purposes.
- 2. A minimum of 20 ft, set back from streets and 5 ft. from the sides shall be observed for construction of residence.
- 3. No structure of a temporary character to be used as a residence including house troilers:
- 4. No noxious or offensive activity shall be carried on upon any lot-
- 5 No livestock or poultry to be raised and kept except dogs, cots and other household pets.
- 6. No lot shall be used for garbage or refuse disposal.
- 7. Covenants can be changed only upon the vote of the majority of lot owners.
- 8. No residential building shall be less than 875 square feet, excluding garage, carport or potio
- 9. No individual or group acting collectively shall be permitted to install a private water supply system.
