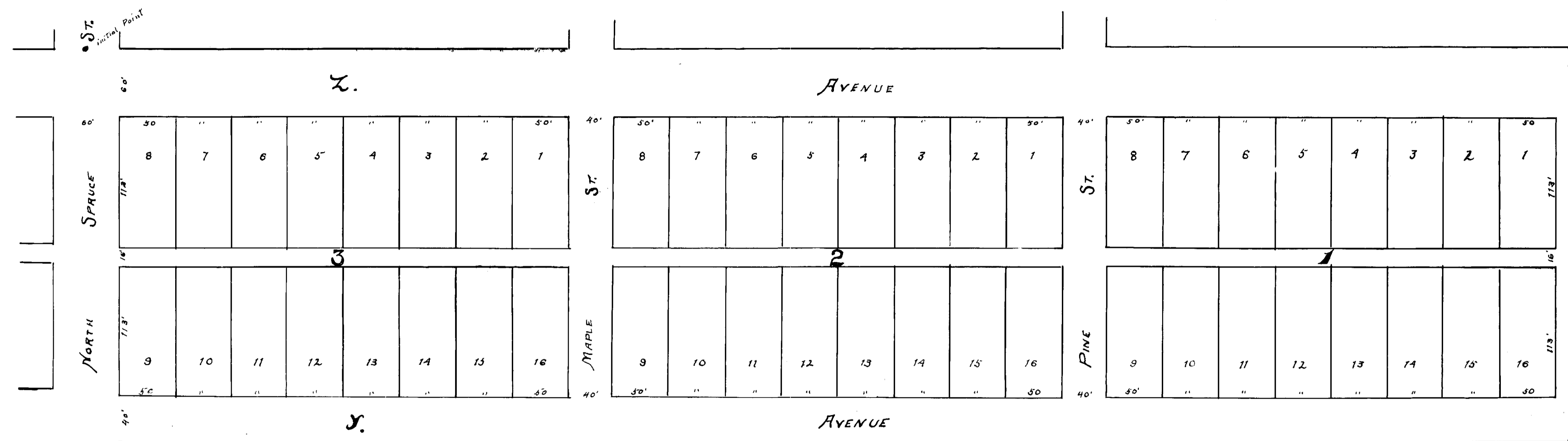


SUGAR ADDITION

KNOW ALL MEN BY THESE PRESENTS, that the Amalgamated Sugar Company, a Corporation, owner of the land platted and described upon the above and to a plat map being a part of Section 5, T. 3, S. R. 38, E. W. M. and more particularly described as commencing at a point 1310 feet South of the Northwest Corner of the N.E. 1/4 of said Section 5, T. 3, S. R. 38, E. W. M. and running thence South 308 feet thence East 1320 feet more or less to the East line of the S.W. 1/4 of N.E. 1/4 of said Section 5 thence North 302 feet thence West 1320 feet more or less to the place of beginning known and platted as Sugar Addition to LA GRANDE, UNION COUNTY, OREGON; does hereby dedicate to public use all parts and parcels of said tract of land represented and marked upon said plat as streets and alleys.

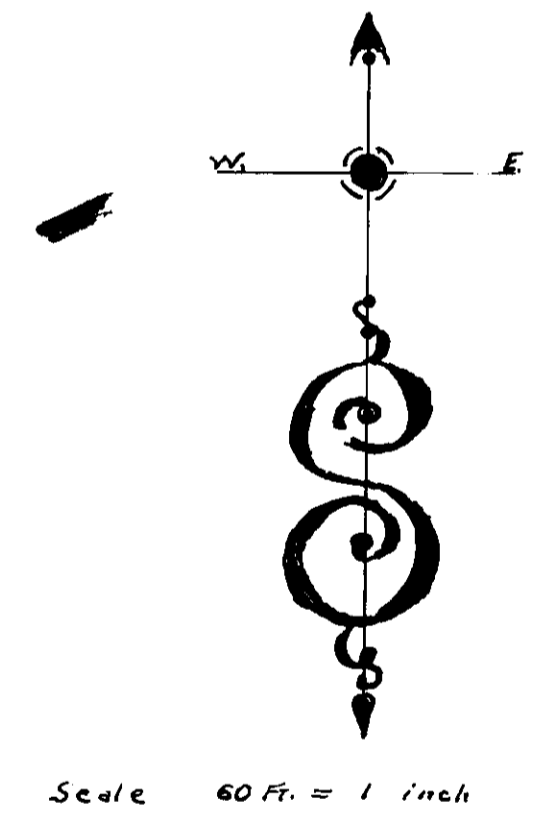
