NARRATIVE

This subdivision was done at the request of Gust Tsiatsos in order to divide the existing tract of land into seven lots and dedicate the right of way for Tilos Court. I use the found monuments of Survey Numbers 57–73, 012–2007, 020–2008 and Minor Partition Plat Number 2001–021 and Major Partition Number 20090013T and 20100010T, to establish the exterior of the partition. I locate the new lots at the direction of Mr. Tsiatsos. This tract of land is subject to a 10 foot access easement along the entire East line of said tract to the La Grande Concrete Pipe Company. I place the power line easement at the record position of microfilm number 20075663. Right of way easement described in MF 20103002 falls off of the property and does not affect lots within this subdivision. I find no other unusual conditions with this plat.
