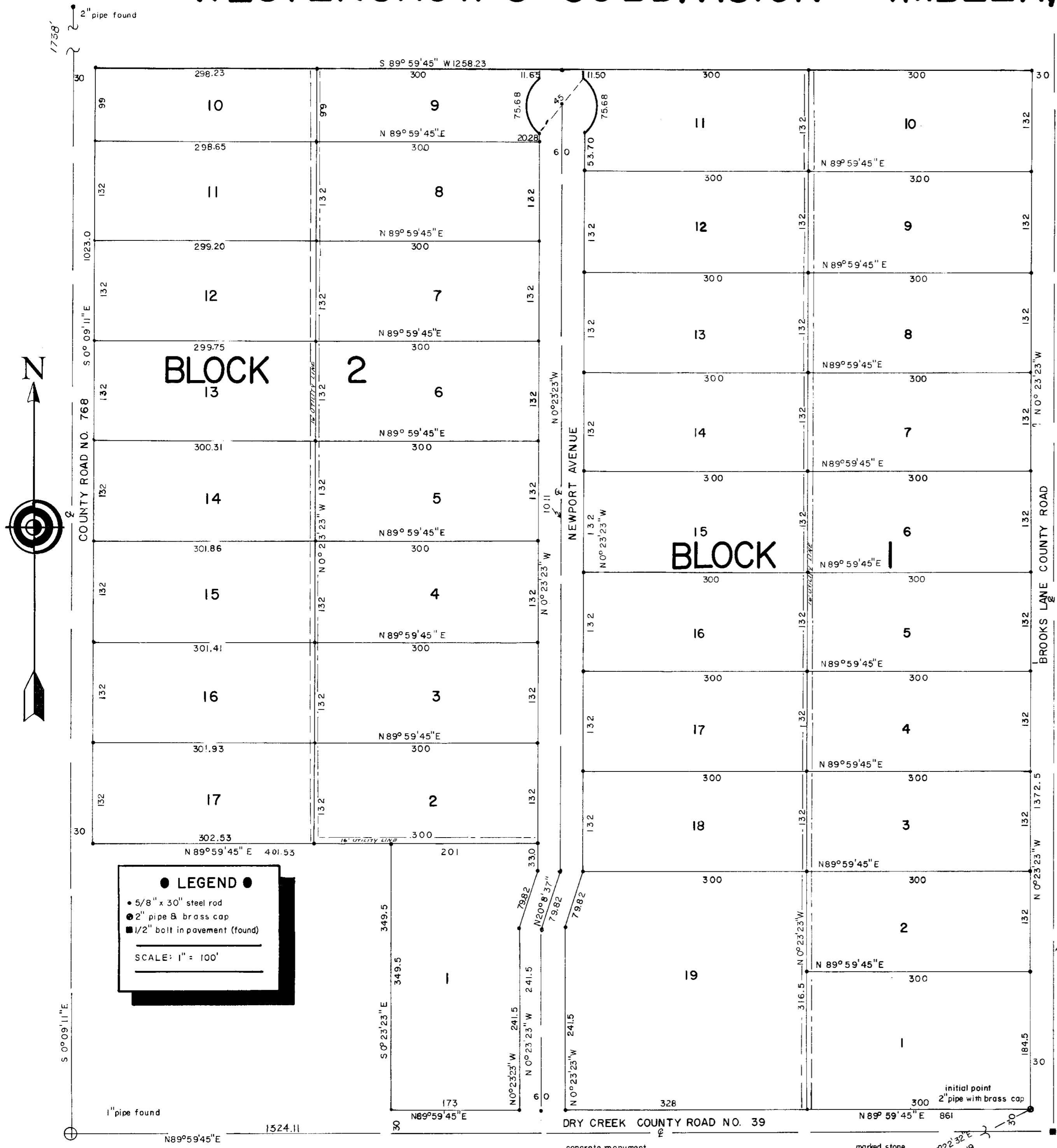


# WESTENSKOW'S SUBDIVISION • IMBLER, OREGON •

**DESCRIPTION:**

I, James G. Voelz, do certify that I am a registered land surveyor in the State of Oregon and surveyed the land as shown on the plat and all corners are placed in accordance with ORS 92.060. The initial point of the survey is designated by a two inch galvanized pipe 36" long with a bronze cap on top marked I. P. Westenskow's subdivision. This point being N44°22'32"E a distance of 3735.19 feet from the southwest corner of section 20 T1S, R39EWM. Initial point being further described as being N0°23'23" W a distance of 30ft. and S 89° 59' 45" W a distance of 30ft. from the center of said section 20. From said point so determined running thence N 0° 23' 23" W 1372.5 ft.; thence S 89° 59' 45" W 1258.23 ft.; thence S 0° 09' 11" E 1023.0 ft. to the north west corner of land as conveyed in Book 126 at page 264 Deed Records of Union County; thence following the north boundary of said deed N 89° 59' 45" E a distance of 401.53 ft. to northeast corner of land as conveyed in Book 100 at page 111 Deed Records of Union County; thence following the east boundary of said deed S 0° 23' 23" E 349.5 ft.; thence N 89° 59' 45" E 861 ft. to point of beginning.
