## NARRATIVE OF SURVEY

This survey was performed at the request of John and Janis Bozarth in order to establish locations for the installation of various residential improvements. The field work was performed on April 28 and 29, 1982 by Gary Langlitz and Rod Scott, using a Wild T-1 Theodolite, electronic-distance measuring device and steel tape.

Monumentation was found as shown along the centerline of Fourth Street. Additional monumentation was searched for at street intersections South and East of this survey location. Sewer manholes were found in these intersections and no street centerline survey monuments were found.

A review of the "Reference Surveys" cited indicate good agreement of existing conditions with the McLain Survey of 1922. Therefore, we base the location of the Bozarth parcel on the found monumentation along Fourth Street and the record relationships shown on the McLain Survey of 1922. The PK nail found at Fifth and "G" Street happens to coincide with our centerline intersection location.
