# NARRATIVE

SURVEY WAS PERFORMED FOR BOSE CASCADE CORPORATION, DURING OCTOBER, 1984. THE SURVEY WAS PERFORMED to SUB-DIMDE THE SECTIONS AND SET 1/16 CORNERS FOR PROPERTY LOCATION. THE SOUTH 1/4 CORNER AND THE SOUTHEAST SECTION CORNER OF SECTION 11, WERE SET FROM ORIGINAL G.L.O. EVIDENCE. NO TRACE OF THE EAST 1/4 CORNER OF SECTION II COULD BE FOUND AND THIS COPNER WAS SET BY SINGLE PROPORTIONATE MEASUREMENT. THE UNE BETWEEN THE NORTH AND SOUTH HALVES, ON THE NORTHEAST 1/4 OF SECTION 10 WAS BLAZED AND PAINTED USING THE OFFSET METHOD, A MACTI-H EDM AND A WILD T-2 WERE USED FOR THE

SECTION 3 WAS SURVEYED BY P.L.S.933, IN 1982 AND FILED AS SURVEY NUMBER 37-82.

THE EXTERIORS OF SECTION 10 AND PART OF THE INTERIORS WERE SURVEYED BY PLS. 991, IN 1983 AND FILED AS SURVEY NUMBER 17-83.

THE CORNER TO SECTIONS 2,3,9 \$ 10
WAS MOVED AFTER THE SURVEY AND THE
BEARINGS AND DISTANCES ARE TO THIS
POSITION.

THE CORNER TO SECTIONS 1,2,11 \$ 12 WAS INCORRECTLY MARKED IN 1980, BUT CHANGED IN 1981, BY ME.
