## NARRATIVE

This survey was ordered by Jay Loudermilk for Wendy's Restaurant. I establish the West line of the parcel by driving the West line of Section 4 from corner to corner. The Southwest corner of the parcel is the South 1/16 corner between Sections 4 and 5. Block 2 of Home Investment Addition was established by survey numbers 54-77 and 5-81. I agree with these positions. I establish the North line of Elgin Avenue from survey number 54-77.

The property from Albany Street East to the freeway and North of Elgin Avenue was owned by William Jeffers. Mr. Jeffers conveyed to Kuensting under memorandum of contract dated September 20, 1976 a portion of this land but held a portion 95 feet wide parallel to the section line. Jeffers later sold this 95 feet to Howard D. McKee under memorandum of contract dated December 16, 1976. McKee recieved a deed from Jeffers recorded May 5, 1977 for this same 95.00 feet. I find that the survey for McDonald's (survey no. 152-78) found a shortage in this distance conveyed to Kuensting and proportioned this across the total area including the McKee property, which is incorrect. Both the Kuensting deed and the McKee deed call for a reservation of this 95 feet. I therefore give the Wendy's property the full 95 foot width called for in the deed.

l establish the North line by driving the South line of the Wallowa Lake Highway Northeasterly as established by survey number 60-75 and intersect the section line and the East line of Wendy's.

Wendy's is required to dedicate a parcel for street purposes on

Wendy's is required to dedicate a parcel for street purposes on the Southwest corner. The curve is to have an 11.00 ft. radius, which I have placed a pin at the P.C. and P.T. of this parcel. At this writing the dedication is not filed.

I find no other problems with this survey.
