SURVEY NARRATIVE

This survey was performed for the Oregon State Board of Higher Education in conjunction with additional developments on the campus of Eastern Oregon State College in La Grande, Oregon.

Sixth Street as shown hereon is located by the position of the intersection of Sixth Street and L Avenue, and by the monument established at the Southeast corner of the parcel shown on Survey No. 18-81. The intersection of Sixth Street and I Avenue is established at the distance shown on Survey No. 18-81. No evidence of the position established by Survey No. 13-76 for the intersection of Sixth Street and K Avenue was found.

L Avenue is located based on the found positions at the intersections of Sixth Street and Eighth Street. Survey No. 71-76 assumes that the position of the intersection of Eighth Street and L Avenue is incorrect, however, this survey is vague in its explanation of the validity of this position. Our measurement of the location of this position relative to Sixth Street show it to be an acceptable position.

The monuments established by this survey at the Northwest corner of Block 48 and along the right-of-way lines of Sixth Street and L Avenue are placed for the convenience of our client in their development of this property. Current records indicate that the Oregon State Board of Higher Education is the owner of the areas shown on this drawing located East of Sixth Street and South of L Avenue. Also, current records indicate that all of the platted streets and alleys in this same area on this drawing have been vacated.
