## SURVEY NARRATIVE

This survey was performed at the request of Mr. James Spicer, Chief Unit Forester, Elgin Timberlands, Boise Cascade Corporation. The purpose of this survey was to determine and document the location of the existing wooden bridge crossing the Minam River relative to the section line between Sections 17 and 18, T1N, R41E.

The Northeast corner of Section 18 was found in good condition as described in Remonumentation records 73-88R. The East 1/4 of Section 18 was also found in good condition. However, we note some minor discrepancies between field conditions and the information given in Remonumentation Record 74-88R. An updated remonumentation record will be filed for this corner to better describe the current condition of this corner.

A random traverse utilizing a one-second theodolite and electric distance measuring device was run between these two corners. The two iron rod monuments were set at computed positions on the line between the 1/4 and section corner. Additional wooden stakes were placed on this section line for a distance of 400+ feet North and South of the bridge. The field survey work was performed on April 19 and April 21, 1988.
