

HISTORY OF SURVEYS

The east range line of Township 2 north was originally established by Rufus S. Moore, Contract number 382 dated March 23, 1881.

The interior of Township 2 North Range 38 East was originally established by Frank W. Campbell, Contract number 468 dated April 12, 1883.

The northeast corner and the southwest corner of section 13 Township 2 north Range 38 east of the Willamette Meridian was remonumented from original GLO Survey evidence by Wayne O. Harris in 1978.

! Duane I. Griffith , registered land surveyor in the State of Oregon hereby certify that this plat and notes hereon, or attached are a true and correct representation of the survey made in July 1989 at the request of USDA Forest Service in accordance with the statutes of the State of Oregon and with the articles of my contract.

) retraced the section lines as shown . I found bearing trees as shown on the remonumentation forms, filed separately. At the NE corner of section 13, the GLO Records do not call for the Southwest and Northwest bearing trees. These were also found by Harris in 1978. I do not find any record of subsequent surveys or remonumentation in the county records. The Northeast tree, which is of record, fits the GLO calls. I see no problem with this. The North 1/4 corner is a proportion, as was unable to find any evidence of the original corner. find no unusual conditions on this survey.
