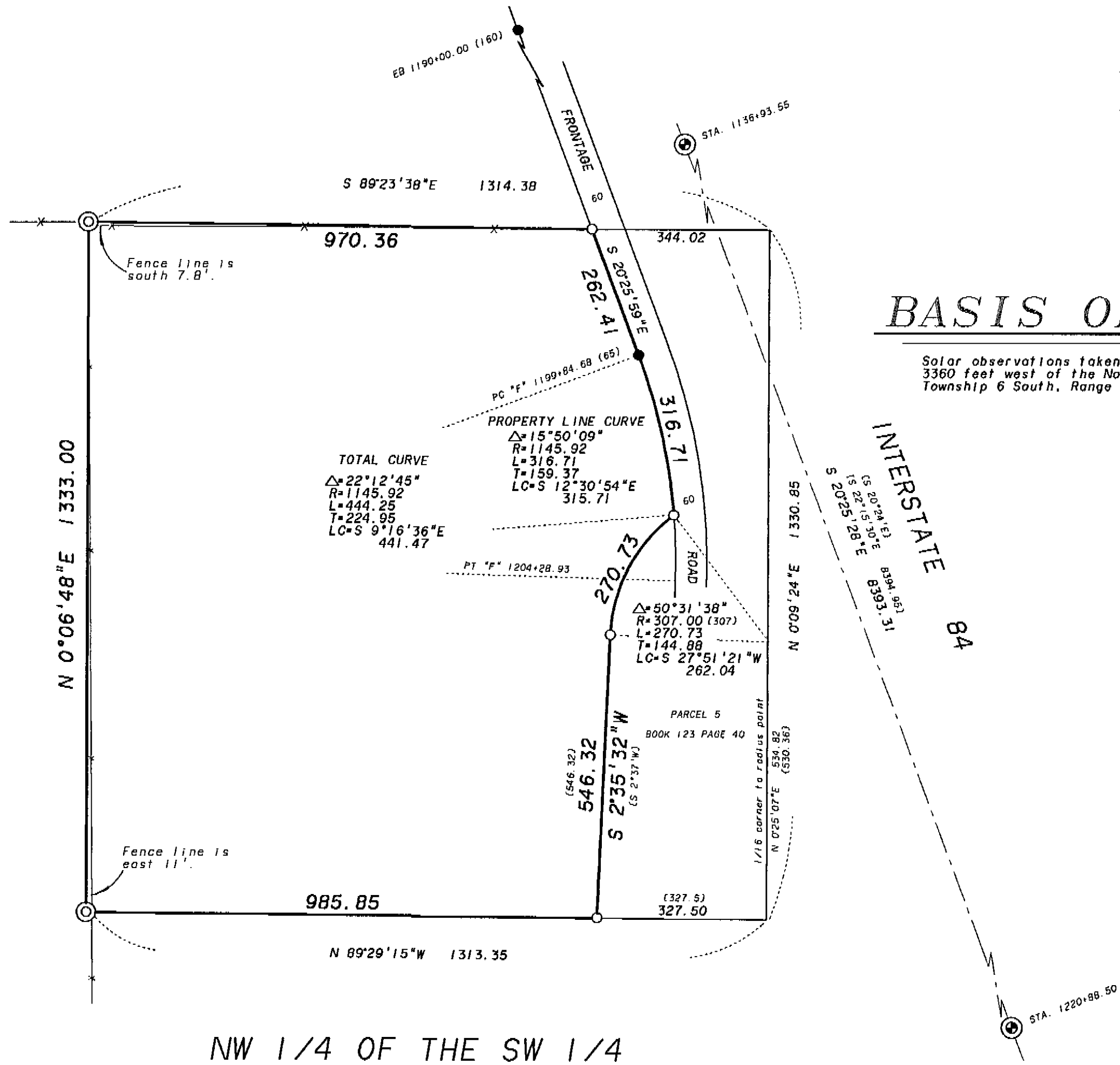


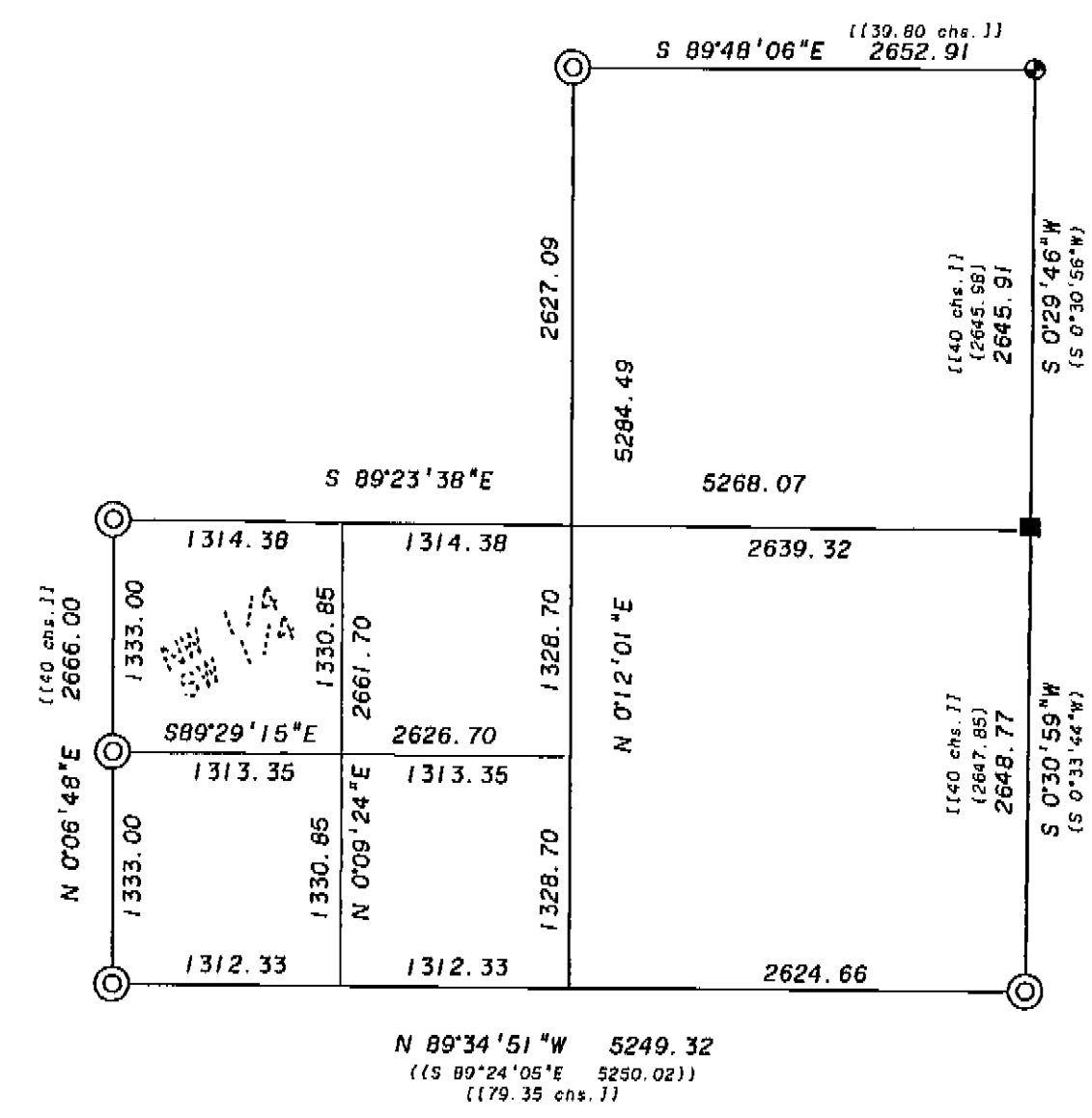

Solar observations taken at a point 3550 feet south and 3360 feet west of the Northeast corner of Section 22, Township 6 South, Range 39 East of the Willamette Meridian.

NARRATIVE

This survey was ordered by Andy Munsey. His tract is described as that portion of the NW 1/4 of the SW 1/4 of Section 22, Township 6 South, Range 39 East of the Willamette Meridian, which lies westerly of the land conveyed to the State of Oregon for the relocated Old Oregon Trail Highway and for interchange of said highway.

The monuments at the Northeast corner and the East 1/4 corner of Section 22 as shown on surveys 040-90 and 064-1991 were found and used. The fence corner used for the Southeast corner of Section 22 by surveys 064-1991 and 9-84 was also used. The fence corner at the Southwest corner of Section 22 as shown on survey 9-84 was also used. Existing fence corners were used to establish the North and West 1/4 corners of this section.

The found ODOT monuments and record curve information were used to place the westerly right of way line of the I-84 frontage road. Part of the land acquired for the interchange is described as Parcel 5 in Deed Book 123 Page 40. The record call of 327.5 feet westerly along the 1/16 line from the SW 1/16 corner was used to place the Southeast corner of this surveyed tract. From this point, after applying a bearing switch using the record centerline bearing given in the description and the found centerline monuments, the line was run Northerly the record bearing and distance of 546.32 feet to the beginning of the curve. The computed radius point of this curve falls within 5 feet of the 1/16 line and of the record call Northerly from the SW 1/16 corner.
