## NARRATIVE

This survey was done at the request of Bart Barlow, on behalf of Boise Cascade Corporation. This tract of land was sold from the surrounding tract, giving it senior rights. The point of beginning of the legal description is the intersection of the South right of way line of the railroad, and the North-South centerline of Section 35. This tract was originally surveyed in 1965 by James Voelz. Mr. Voelz did not properly subdivide Section 35 for the location of his monuments. This was also called in survey number 77-80, which truly located the controlling section corners. Subsequent surveys have upheld the position determined by survey number 77-80. I place the Northwest corner of the tract on the South right of way line of the railroad, at record distance (1519.82 ft.) from the true Northeast corner of the property. I used the existing monuments from the surveys shown to place the right of way. The Southwest corner was also placed at the record distance (1272 ft.) South and parallel with the North-South centerline of Section 35, as per the deed record. The Southeast corner was also placed at record distance from the true Northeast corner. The South line of this tract is a more or less call in the deed, connecting the Southeast and Southwest corners as previously described. I find no other unusual conditions on this survey.
