


This survey was performed at the request of Steve Gurnsey on behalf of BOISE CASCADE CORPORATION. Mr. Gurnsey wished to monument the corners of BOISE CASCADE CORPORATION's ownership in Section 5, Township 2 South, Range 40 East of the Willamette Meridian. This area has been logged heavily and there is virtually no evidence remaining of original GLO corners. The North line of Section 5 was established by Survey No. 37-86. I find the bearings and distances between said survey and this survey to differ as shown. Ancient blaze lines and supporting topo calls were used to establish the section corner common to Sections 5, 6, 7, and 8. Using this position I subdivided the section using standard proportionate procedure outlined in the 1973 BLM Manual of Surveying Instructions. I found the proportionate positions to fit the topo calls very well. I find no other problems with this survey.
