


NARRATIVE

This survey was performed at the request of John Manwell on behalf of Boise Cascade Corporation. Mr. Manwell wanted to determine if the monuments on the North side of Boise Cascade Corporation's property had been moved. He also wanted to blaze the North and East lines of the said property. I base the location of the North and East lines on Survey No. 1—81. I found blaze lines on the North and East boundary. These were run sometime after Survey No. 1—81. These blaze lines are accurate and harmonious with my retracement of Survey No. 1—81. The original monuments of Survey 1—81 on the North line had been moved as indicated. I reset new monuments and freshened the blazes along the North and East lines. The existing fencelines are away from the property lines as shown. I find no other problems with this survey.

The distance to the bearing tree is to a 50d spike driven on the right side of the tree at the root crown. I attached a brass washer marked OPLS 2219 to the BT blaze.
