

NARRATIVE

This survey was done at the request of Hanley Jenkins, Union County Planner on behalf of Union County. The purpose of this survey is to monument the dedication of Eagle Drive. The parcels in this area have been created through a series of partitions. Major Partition Plat Number 1993-06 created a 50 ft. non-exclusive easement for access and utilities now known as Eagle Drive, with the Northerly terminus being the North line of Parcel 1 of the 1993 partition. Major Partition Plat Number 1997-01 created Eagle Drive from that point to its present Northerly terminus as a dedicated roadway. The County wished to have the Southerly portion of Eagle Drive also dedicated to the public. I use the existing monuments from the partitions listed in the reference material to place the area to be dedicated. The two Easterly pins at the North end of the dedication have been destroyed. I reset them at the record position of the previous partitions. The preliminary title reports listed in the reference material treat Buchanan Lane as an easement, with the underlying fee belonging to the owners of Parcel 1 of Major Partition Plat Number 1993-06. I therefore show the dedication as going to the Centerline of Buchanan Lane, which is the South line of Section 3. All of the area within this dedication is within the fee title of Parcel 1 of Major Partition Plat Number 1993-06. I have prepared a legal description of this dedicated area for the legalization process. find no unusual conditions on this survey.
