NARRATIVE

This survey was done at the request of Stan Wilde, on behalf of Boise Cascade Corporation. The purpose of this survey was to mark the property line within the Southwest quarter of Section 31 and the Northwest quarter of Section 6. This area has had previous surveys in these sections as shown. The main area of confusion in these sections is the placement of the West half of the sections. There was an apparent error in the original surveys in these sections. This was discussed at length on survey number 31-86, which placed the West 1/16th corner between Sections 31 and 6. The error was also documented by the J.W. Kimbrell survey on page 57 of the old book of surveys. The controlling corners of Section 31 were in place, with the Northwest corner and West 1/4 corner of the section being previously placed mathematically, but not monumented. Many corners within Section 6 were previously monumented, but never correlated to each other. I did need to place the East 1/4 corner of Section 6. The area of this corner has been logged many times. I found no evidence of the original corner stone. I did find the remains of an ancient fence line running East and West through the area. In studying this area, it appears the Northerly 1/2 mile of the Sections in Township 5 South are short of the original GLO Survey dimensions. The ancient fence also reflects this trend. I place the East quarter corner of Section 6 at the intersection of the line between the Northeast and Southeast corners of the Section and the ancient fence line. I then subdivide the sections according to the BLM Manual. The existing fence along the posted line varies as shown. It appears the fence builders were unaware of the drastic shift in bearing along this line. I find no other unusual conditions on this survey.


