



NARRATIVE

This survey was performed at the request of Blaine Kelly on behalf of Oregon State University. Mr. Kelly wanted to locate the West right of way of 10th Street to prepare for an expansion of the Oregon State University (OSU) Experimental building. In my research of deeds I found OSU's ownership extends to the East line of the West 1/2 of the Northeast 1/4. I found no dedication or reservation for a road right of way or easement West of said line. The road has been in use over 50 years and a prescriptive right for a non-exclusive easement to the public exists. The existing fence line is the best available evidence of the location of the prescriptive easement and I set pins in the corners and angle points of said fence of said prescriptive easement. The South line of Co. Road No. 12 I place an a 30 foot perpendicular offset to the North line of the East 1/2 of Section 24. I intersected the South line of Co. Road No. 12 with the extension of the North-South fence along 10th Street to place the most northerly pin. I accepted found pins of Survey No. 20—81 for the placement of Grande Avenue. I intersected the North-South fenceline of 10th Street with the South line of Grande Avenue for the placement of the most Southerly pin. The southern most pin does not mark the terminus of OSU's property. I set the southern pin to determine direction for the prescriptive easement along 10th Street. I would suggest that OSU either dedicate or create an easement for road purposes at a uniform width, parallel to the East line of said West 1/2 of the Northeast 1/4. I find no other problems with this Survey.
