

# SURVEYOR'S NARRATIVE


THIS SURVEY WAS PERFORMED AT THE REQUEST OF THE NATURAL RESOURCE CONSERVATION SERVICE FOR THE PURPOSE OF DEFINING THE LIMITS OF A WETLANDS CONSERVATION EASEMENT. PARCELS TWO AND FIVE COMPRISE THE EASEMENT LIMITS WITH PARCELS ONE, THREE, AND FOUR EXCLUDED THEREFROM.


THE LEGAL DESCRIPTION FOR THE PARENT PARCEL WAS SUPPLIED BY EASTERN OREGON TITLE, INC. IN PRELIMINARY TITLE REPORT #00-11904. AND IS DESCRIBED AS THE SOUTHWEST ONE-QUARTER AND THE WEST ONE-HALF OF THE NORTHWEST ONE-QUARTER OF SECTION 28 AND THE NORTHWEST ONE-QUARTER AND THE NORTH ONE-HALF OF THE SOUTHWEST ONE-QUARTER OF SECTION 33, TOWNSHIP 3 SOUTH. RANGE 39 EAST OF THE WILLAMETTE MERIDIAN, UNION COUNTY, OREGON.

THE WEST LINE OF SECTION 33 WAS MONUMENTED BY UNION COUNTY SURVEY #27-90 AND THOSE MONUMENTS CONTROL THIS SURVEY. A THOROUGH SEARCH WAS MADE FOR THE ORIGINAL MONUMENTS IN THESE SECTIONS WITHOUT SUCCESS. THIS SURVEY USES EXISTING FENCES TO DEFINE LIMITS OF OWNERSHIP WITH THE EXCEPTION OF THE NORTH LINE OF SECTION 28 WHERE THE CENTERLINE OF AIRPORT LANE PROJECTED EASTERLY WAS USED. THIS WAS DONE BECAUSE IT WAS FELT THAT THE FENCES AND ROADS NOW EXISTING ARE THE BEST AVAILABLE EVIDENCE FOR THE POSITION OF THE ORIGINAL CORNERS NOW LOST. A SUBDIVISION OF THESE LANDS ACCORDING TO THE MANUAL OF INSTRUCTIONS FOR THE SURVEY OF PUBLIC LANDS OF THE UNITED STATES, BY PRORATION FROM CORNERS FAR DISTANT WOULD

THE RIGHT-OF-WAYS FOR ALL COUNTY ROADS WERE EXCLUDED FROM THE EASEMENT DESCRIPTION. COUNTY ROAD #215 WAS OPENED IN NOVEMBER OF 1884 BUT NEVER CONSTRUCTED. A SEARCH OF PUBLIC RECORDS COULD FIND NO EVIDENCE OF VACATION SO IT TOO WAS EXCLUDED FROM THE EASEMENT DESCRIPTION.

THE PARCELS SHOWN HEREON ARE DEPICTED FOR THE PURPOSE OF DEFINING EASEMENT BOUNDARIES ONLY. THIS MAP SHOULD NOT BE INTERPRETED AS CREATING NEW PARCELS OF LAND FOR ANY PURPOSE WHICH WOULD BE IN VIOLATION OF STATE OR LOCAL STATUES.











### PARCEL 1




