**NARRATIVE** 

This Lot Line Adjustment was done at the request of Joel and Leslie Hasse. The purpose is to adjust a portion of what is now tax lot 3400 into what is now tax lot 3300. Tax Lot 3400 is now described as all of Lot 33 excepting the North 100 feet. Tax Lot 3300 is now described as all of Lot 40 except the West 80 feet of the South 160 feet. This adjustment will reduce Tax Lot 3400 and increase Tax Lot 3300. The West line of the adjusted parcel was made to be the existing fence line at the instruction of the owners. I find the fences relative to the property as shown. I find no other unusual conditions on this partition.
