NARRATIVE

This survey was done at the request of Phil Burling on behalf of the owners of the land within this Lot Line Adjustment. I use Minor Partition Plat Number 1997–07 for the control of the exterior of Block 6 of Honan's Addition to LaGrande. I then establish the lots by standard proportion. I find the Smith tract to be all of Lot 4 of Block 6 excepting the South 100 feet, along with the South 42.5 feet of Lot 1 of said Block. The White tract is Parcel 1 of Minor Partition Number 1997–07. The purpose of this survey is to adjust the White ownership out into the Smith tract, increasing the size of the White tract, and reducing the Smith tract in size. The 20 x 100 ft. strip accruing to the White tract is to be an easement for ingress and egress to the Smith tract after adjustment. I find the existing fences to relate to the true ownership lines as shown. I find no other unusual conditions on this survey.
