## NARRATIVE

This survey was ordered by Mick McClure for the purpose of defining property for lease purposes. Mr. McClure intends to construct airplane hangars on the lease. Mr. McClure and Union County Airport Manager Dennis Spray pointed out the area intended for a lease, and told me to make sure that the existing leases did not overlap on the McClure Lease. I find that the Forest Service Lease "A" was expanded by Tract "J", extending the original Lease "A" southerly 270 feet. I also find that a written lease ( but not yet in place ) for Sustainable Energy Development, Inc. conflicts in its entirety on Tract "J", and should be rewritten. I have placed the McClure Lease concurrent with the South Line of said Tract "J". The building restriction line referred to as BRL, is defined as being 425 feet West of and parallel to the centerline of runway 16/34. I tied the painted centerline of said runway and draw a parallel line 425 feet west of the tied line to establish the restriction line. I find no other unusual conditions with this survey.
